**RESOLUTION AUTHORIZING HONORABLE CITY
MAYOR CARMELITA "MENCHIE" A. ABALOS TO
ENTER INTO AND SIGN A MEMORANDUM OF
AGREEMENT WITH THE DEPARTMENT OF SOCIAL
WELFARE AND DEVELOPMENT (DSWD) – FIELD
OFFICE NATIONAL CAPITAL REGION FOR THE
IMPLEMENTATION AND DISTRIBUTION OF THE
SOCIAL PENSION FOR THE INDIGENT SENIOR
CITIZENS (SPISC) IN THE CITY OF MANDALUYONG**

WHEREAS, it is the declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social service, among others, and an improved quality of life;

WHEREAS, Article XIII, Section 11 of the Constitution provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, and elderly;

WHEREAS, Republic Act No. 9994, otherwise known as the Expanded Senior Citizens Act of 2010, as amended by Republic Act No. 11916, provides for the increase and grant of Social Pension to indigent senior citizens entitling them to a monthly stipend amounting to not less than One Thousand Pesos (Php 1,000.00) to augment the daily subsistence and other medical needs of senior citizens;

WHEREAS, the Department of Social Welfare and Development (DSWD) is the primary national government agency mandated to implement the Social Pension for Indigent Senior Citizens (SPISC) Program nationwide;

WHEREAS, pursuant to its mandate under Section 17 of Republic Act No. 7160, or the Local Government Code, LGUs shall discharge functions and responsibilities as are necessary, appropriate or incidental to the efficient and effective provisions of basic services such as social welfare services which include programs and projects on welfare of the elderly, among other sectors;

WHEREAS, the City Government of Mandaluyong, through its City Social Welfare and Development Department (CSWDD) and Office for Senior Citizens Affairs (OSCA), actively supports national government programs aimed at promoting the welfare, protection, and social security of senior citizens;

WHEREAS, the DSWD Field Office-National Capital Region requires the execution of a Memorandum of Agreement (MOA) with the Local Government Unit to clearly define the roles, responsibilities, and coordination mechanisms in the implementation and distribution of the Social Pension within the locality;

WHEREAS, entering into said MOA will ensure the efficient, transparent, and timely distribution of social pension benefits to qualified indigent senior citizens in the City of Mandaluyong;

WHEREAS, the City Mayor is the Chief Executive of the City and is authorized to represent the City Government in contractual and inter-agency agreements, subject to authorization by the Sangguniang Panlungsod.

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in a session duly assembled, to AUTHORIZE the Honorable City Mayor, Carmelita "Menchie" A. Abalos, to enter into and sign a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Field Office National Capital Region for the implementation and distribution of the Social Pension for Indigent Senior Citizens (SPISC) in the City of Mandaluyong.

RESOLVED FURTHER, to DIRECT the City Social Welfare and Development Department (CSWDD), Office for Senior Citizens Affairs (OSCA), and other concerned City offices to provide assistance, coordination, and support to DSWD in the effective implementation of the Social Pension Program.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, DSWD Field Office-NCR, CSWDD, OSCA, and all concerned offices for their information and appropriate action.

ADOPTED on this 23rd day of February 2026, in the City of Mandaluyong.

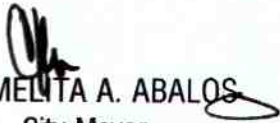
