RESOLUTION NO. 3783, S-2026

A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR CARMELITA A. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH MAHARLIKA PILIPINAS BASKETBALL LEAGUE – BIDA BARANGAY, THROUGH ITS COMMISSIONER MR. LORETO F. TOLENTINO, FOR THE CONDUCT OF THE MPBL BIDA BARANGAY LIGA, A BARANGAY-BASED BASKETBALL LEAGUE WITHIN THE CITY OF MANDALUYONG

WHEREAS, Republic Act No. 7160 otherwise known as or the Local Government Code of 1991 empowers local government units to promote the general welfare and undertake programs that encourage sports development, youth engagement, and community wellness;

WHEREAS, sports activities serve as a vital platform for youth development, community participation, and the promotion of healthy lifestyles among residents;

WHEREAS, the Maharlika Pilipinas Basketball League (MPBL) Bida Barangay Liga is a grassroots basketball initiative designed to organize competitive basketball tournaments among barangays and local communities;

WHEREAS, the proposed league aims to promote sportsmanship, camaraderie, and unity among barangays nationwide while encouraging active participation in community-based sports programs;

WHEREAS, the City Government of Mandaluyong recognizes the importance of supporting initiatives that promote sports development and constructive youth activities, thus the initiative of MPBL to hold the Bida Barangay Liga and execute a Memorandum of Agreement for the same;

WHEREAS, the proposed Memorandum of Agreement provides that the conduct of the MPBL Bida Barangay Liga shall not entail any financial obligation on the part of the City Government, with all operational expenses to be shouldered by the league organizer through registration fees and related sources;

WHEREAS, in view of the same, the Agreement, which was drafted in order to espouse the intent of the parties to facilitate arrangement, has already been reviewed by the City Legal Department and upon review of its provisions, is considered legally in order;

WHEREAS, the Local Government Code requires that a Sangguniang Panlungsod Resolution be issued first before the Local Chief Executive may be authorized to sign contracts in representation of the local government unit;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor Carmelita A. Abalos to enter into and sign the Memorandum of Agreement with Maharlika Pilipinas Basketball League – Bida Barangay, through its commissioner Mr. Loreto F. Tolentino, for the conduct of the MPBL Bida Barangay liga, a barangay-based basketball league within the City of Mandaluyong

RESOLVED FURTHER, that the participation of the City Government shall be limited to providing venue support and coordination for safety and security, and that the conduct of the league shall be at no cost to the City Government;

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Office of the City Mayor and other concerned offices for their information and appropriate action.
