A RESOLUTION ADOPTING LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) RESOLUTION NO. 7, SERIES OF 2025, ENTITLED: "A RESOLUTION ADOPTING THE MANDALUYONG CITY DEVELOPMENT PLAN FOR CHILDREN (MCDPC) 2026–2030"

WHEREAS, the Local Council for the Protection of Children (LCPC) issued Resolution No. 7, Series of 2025 adopting the Mandaluyong City Development Plan for Children (MCDPC) 2026–2030;

WHEREAS, the Mandaluyong City Development Plan for Children seeks to provide a structured framework for the holistic growth, protection, welfare, and development of children and to address their unique needs and challenges through responsive programs and services;

WHEREAS, the implementation of child-centered programs and initiatives is consistent with the policies of the State and the City Government of Mandaluyong in promoting and safeguarding the rights and welfare of children;

WHEREAS, the adoption of the Mandaluyong City Development Plan for Children (MCDPC) 2026–2030 forms part of the City Government's compliance with the Child-Friendly Local Governance Audit and other related laws, rules, regulations, and policy issuances;

WHEREAS, the MCDPC 2026–2030 identifies key challenges affecting children in the areas of survival, protection, development, and participation rights, including malnutrition, mental health concerns, school participation, child abuse, adolescent pregnancy, and disaster-related vulnerabilities;

WHEREAS, the Honorable City Council finds the adoption of the aforesaid development plan beneficial to the best interests of children and supportive of the City's continuing efforts toward child-friendly governance.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the City Council of Mandaluyong, in session duly assembled, to adopt Local Council for the Protection of Children Resolution No. 7, Series of 2025, entitled: "A Resolution Adopting the Mandaluyong City Development Plan for Children (MCDPC) 2026–2030."

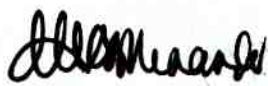

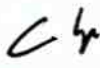

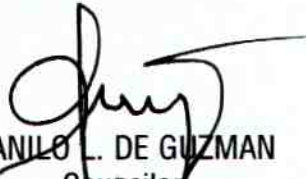
