**ORDINANCE NO. 809, S-2020**

AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 658, S-2017 ENTITLED: "AN ORDINANCE GRANTING CASH GIFT OF THREE HUNDRED PESOS (P300.00) TO ALL RESIDENT AND REGISTERED SENIOR CITIZENS OF MANDALUYONG CITY EVERY ANNIVERSARY OF HIS OR HER BIRTH AS A TOKEN OF APPRECIATION AND CARE BY THE CITY OF MANDALUYONG", BY INCREASING THE BIRTHDAY CASH GIFT FROM THREE HUNDRED PESOS (P300.00) TO FIVE HUNDRED PESOS (P500.00)

WHEREAS, it is the commitment of the City Government of Mandaluyong to protect and maintain the welfare of the elderly, especially in this time of pandemic;

WHEREAS, recognizing their invaluable contribution, the City of Mandaluyong deems it proper to increase the provision of birthday cash gift of our senior citizens as additional support to their medication and sustenance.

BE IT ORDAINED, by the Sangguniang Panlungsod, in session assembled, do hereby state:

SECTION 1. Section 1 of Ordinance No. 658, S-2017 is hereby amended to increase the amount of the birthday cash gift of all the resident and registered senior citizens of the City of Mandaluyong, to read as follows:

"SECTION 1. CASH GIFT – All resident and registered senior citizens in the City of Mandaluyong shall be granted a yearly birthday cash gift in the amount of Five Hundred Pesos (P500.00)."

SECTION 2. After approval, the amount needed to implement this Ordinance shall be taken from the available funds of the Office Senior Citizens Affairs (OSCA) of Mandaluyong City, subject to auditing and accounting rules and regulations. The OSCA shall, thereafter, include in their budget the appropriations for birthday cash gift of the resident and registered senior citizens of Mandaluyong City for the ensuing calendar year.

SECTION 3. The Ordinance shall take effect on January 1, 2021.
