**ORDINANCE NO. 463, S-2011**

AN ORDINANCE RENAMING E. RODRIGUEZ STREET  
TO JAIME CARDINAL SIN STREET

WHEREAS, the late JAIME L. CARDINAL SIN, Archbishop of Manila from 1974–2003, was looked upon as a great leader, patriot and church dignitary, having contributed much in the restoration of democracy to the Filipino people during EDSA I;

WHEREAS, year 2011 will mark the 25th Anniversary of the historic EDSA I People Power Revolution. It is an occasion worth remembering by all Filipinos to remind them of patriotism and moral crusade for good governance. EDSA I is a gift of God to the Filipino people that must be constantly nurtured and safeguarded;

WHEREAS, JAIME L. CARDINAL SIN was a prominent resident of Mandaluyong City for thirty one (31) years. He was not a passive resident of the City as he spearheaded, during his lifetime, numerous spiritual, socio-civic and community activities like free clinics, educational assistance, gift giving to the poor, catechism for children, livelihood training programs and others which benefited the citizens regardless of religious affiliation. He gave the City of Mandaluyong great honor through his achievements both as church leader and national figure. His presence and leadership, and his choice to reside at Villa San Miguel, has given additional prestige and recognition to the beloved City of Mandaluyong;

WHEREAS, various celebrations marking the Silver Jubilee of EDSA I have been lined up in different cities and provinces. It is strongly submitted that the City must also have its share of commemoration. One such gesture to bestow honor and gratitude to a great citizen of the City in particular, and the country, in general, such as the late Jaime Cardinal Sin, is to name a street for and in his honor.

BE IT ORDAINED, THEREFORE, by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. This is an Ordinance renaming E. RODRIGUEZ STREET to JAIME CARDINAL SIN STREET;

SECTION 2. The E. Rodriguez Street in Barangay Pleasant Hills shall, henceforth, be known as JAIME CARDINAL SIN STREET. It is expressly herein provided, however, that the street sign to be installed, to effect the change, shall indicate its former name, i. e., E. Rodriguez St. beneath the new name JAIME CARDINAL SIN STREET, as follows:

JAIME CARDINAL SIN STREET  
(formerly E. Rodriguez Street)

SECTION 3. Let copy of this Ordinance be furnished each the following government agencies and instrumentalities, for record and other official purposes, to wit:

- a. National Historical Commission of the Philippines;

- b. The Mandaluyong City Planning and Development Office for its information and corresponding change and annotation in the Official Political Map of the City of Mandaluyong;
- c. The Mandaluyong City Engineering Department for its information, preparation and installation of a new street sign;
- d. Philippine Postal Corporation, Mandaluyong City Office;
- e. Department of Transportation and Communication; and
- f. The Barangay Council of Pleasant Hills.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
