RESOLUTION NO. 3738, S-2026

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE CARMELITA A. ABALOS, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION RELATIVE TO THE IMPLEMENTATION OF THE BASIC EDUCATION FACILITIES PROGRAM IN THE CITY OF MANDALUYONG

WHEREAS, the Department of Education (DepEd) is the primary government agency mandated to formulate, implement, and coordinate policies, plans, programs, and projects in the areas of formal and non-formal education;

WHEREAS, under Section VIII (Department of Education), Special Provision No. 6 of Republic Act (RA) No. 12314, otherwise known as the General Appropriations Act of 2026 ("GAA 2026"), DepEd may enter into a Memorandum of Agreement (MOA) with other government agencies, including qualified LGUs, for the implementation and construction of Basic Education Facilities;

WHEREAS, the City of Mandaluyong desires to collaborate with DepEd in implementing school building projects to address classroom shortages in public schools within the territorial jurisdiction of the City of Mandaluyong;

WHEREAS, under Section 22 of RA No. 7160, otherwise known as the Local Government Code of 1991 (LGC), the corporate powers of LGUs include:

"Section 22. Corporate Powers. –

- (a) Every local government unit, as a corporation, shall have the following powers

xxx

- (5) To enter into contracts; and

xxx

- (c) Unless otherwise provided in this Code, no contracts may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned."

WHEREAS, under Section 455(b)(vi), Article I, Chapter III, Title III of the LGC further provides:

"Section 455. Chief Executive; Powers, Duties and Compensation.

xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the city mayor shall:

- (1) Exercise general supervision and control over all programs, projects, services, and activities of the city government and in this connection, shall:

xxx

- (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang panlungsod or pursuant to law or ordinance;"

NOW, THEREFORE, the Sangguniang Panlungsod of Mandaluyong, in session assembled and on motion duly seconded, RESOLVED, as it hereby RESOLVES, to authorize the Local Chief Executive, Honorable Carmelita A. Abalos, to enter into a MOA with DepEd for the construction, replacement, reconstruction, rehabilitation, repair, and improvement of classrooms and school building projects within our territorial jurisdiction;

RESOLVED FURTHER, to authorize the Honorable City Mayor Carmelita A. Abalos to execute and perform all acts necessary to give full effect to the MOA;

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, to DepEd, and other offices concerned for their information and reference.

ADOPTED on this 4th day of February 2026, in the City of Mandaluyong.


