ORDINANCE NO. 847, S-2021

**AN ORDINANCE IMPLEMENTING THE
QUALITY MANAGEMENT SYSTEM
(QMS) IN ACCORDANCE WITH THE ISO
9001:2015 STANDARDS**

WHEREAS, Administrative Order No. 161, Series of 2006, institutionalized the Quality Management System (QMS) in the Philippines by mandating the establishment of an ISO-aligned QMS;

WHEREAS, Executive Order No. 605, Series of 2007, amended AO No. 161 enjoining LGUs to adopt ISO-QMS as standard of ensured quality public service and pursue certification;

WHEREAS, by virtue of Executive Order No. 30, Series of 2020, the City of Mandaluyong, through the Office of the City Mayor, institutionalized the 2020 Government Quality Management Program (GQMP), Organizing the Quality Management System Committee, Core Team, and Technical Secretariat;

WHEREAS, the aforementioned Executive Order was further amended by Executive Order No. 38, Series of 2021 which revised the membership of the Internal Quality Audit Team;

WHEREAS, in order to realize the commitment of the City to the institutionalization of the Quality Management System based on the ISO 9001:2015 Standards and its continuity, it is necessary that the measures developed during the GQMP by the Management Representative, Technical Secretariat Team, and the QMS Core Teams for this purpose be implemented through this Order;

WHEREAS, based on Section 16 of the Local Government Code, every local government unit, including the barangay, has the implied power to do all things necessary, appropriate, or incidental to govern efficiently and effectively, promote general welfare, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Sangguniang Panlungsod ng Mandaluyong expresses its full support to the Office of the City Mayor in the implementation of the Quality Management System in the whole City Government of Mandaluyong to aid the provision of public service and promote compliance with the compliance with the ISO-9001:2015 Standards.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

Section 1. Pursuant to the policy enunciated by the National Government in the implementation of an ISO-based Quality Management System (QMS), the City Government of Mandaluyong is hereby mandated to comply with the directives by the proper authorities in the adoption of QMS for the enhanced efficiency in the provision of public service by the City.

Section 2. The measures already set in place by the City Government for purposes of the implementation of the QMS is hereby confirmed by the Sangguniang Panlungsod ng Mandaluyong.

Section 3. In accordance with the national policy on the pursuit of certification of an ISO-based QMS, the City Government of Mandaluyong shall undertake such endeavor and ensure compliance with the ISO-9001:2015 Standards through the creation of appropriate Teams for its oversight and maintenance.

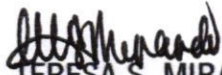
Section 4. If any provision of this Ordinance is determined to be invalid, illegal or unenforceable, its remaining provisions shall remain in full force as though this Ordinance did not originally include such invalid, illegal or unenforceable provision.

Section 5. This Ordinance shall take effect immediately upon approval, and shall remain in full force and effect until and unless repealed or otherwise suspended by a subsequent Ordinance on the matter.

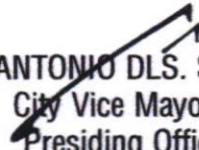
