RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO SIGN THE PROJECT CONTRACT WITH TACTICAL BUILDERS, INC. FOR THE DEMOLITION OF EXISTING HIGHWAY HILLS BARANGAY HALL LOCATED AT MARIVELES STREET CORNER BANAHAW STREET, BARANGAY HIGHWAY HILLS, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the demolition of existing Highway Hills Barangay Hall located at Mariveles Street corner Banahaw Street, Barangay Highway Hills, City of Mandaluyong;

WHEREAS, on February 3, 2026, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein the lone bidder participated by submitting its abstract of the proposal to the Bids and Awards Committee;

WHEREAS, in the aforesaid public bidding, the firm doing business under the name of Tactical Builders, Inc., with business address at Unit 2A Alpha Square Building, No. 130 A. Sandoval Avenue, Barangay San Miguel, Pasig City has been established to have the Single Calculated and Responsive Bid (SCRB) in the amount of TWO MILLION SEVENTY TWO THOUSAND PESOS (₱2,072,000.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.


NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of Tactical Builders, Inc. is the Single Calculated and Responsive Bid and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor Carmelita A. Abalos, to sign the Project Contract with Tactical Builders, Inc. for demolition of existing Highway Hills Barangay Hall located at Mariveles Street corner Banahaw Street, Barangay Highway Hills, City of Mandaluyong.
