



RESOLUTION NO. 3797, S-2026

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMELITA “MENCHIE” A. ABALOS, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) FOR THE IMPLEMENTATION AND UTILIZATION OF THE GREEN GREEN GREEN PROGRAM PURSUANT TO LOCAL GOVERNMENT SUPPORT FUND (LGSF)-GAA FY 2025 UNDER REPUBLIC ACT NO. 12116

WHEREAS, the State recognizes the problem of urban decay as well as the lack of open and green spaces in Metro Manila, and found solution by contributing to the need to promote and develop open and green, which acknowledges the vital role of Local Government Units (LGUs) in promoting ecological balance, sustainable urban development, and climate resilience;

WHEREAS, the National Government, pursuant to the Local Government Support Fund (LGSF) under the FY 2025 General Appropriations Act (GAA), specifically Republic Act No. 12116, provides or appropriated financial assistance to the identified LGUs and beneficiaries within the Metro Manila for the implementation of the Green Green Green Program (GGG);

WHEREAS, LGSF-GGG Program aims to promote green, sustainable, and climate-resilient public spaces through the provision of technical assistance and support, through the funding of projects i) open spaces such as public/municipal parks and plaza, nature and family/recreational parks, arboretum, botanical gardens, and river esplanades; and ii) infrastructure for active mobility such as physical separated bicycle lanes, bike racks, elevated or at-grade pedestrian footpaths and walkways, sport facilities, and recreational trails;

WHEREAS, the City Government of Mandaluyong is one of the beneficiaries under the GGG Program of FY 2025 GAA, and the recipient of the Local Government Support Fund (LGSF) to implement the program subject to the provisions of the Department of Budget Management (DBM) Local Budget Circular No. 164, or the Guidelines on the Release and Utilization of the LGSF-GGG Program funds;

WHEREAS, the City Government, as an LGU, pursuant to its mandate under Republic Act No. 7160, or the Local Government Code of 1991 (LGC), shall exercise powers and discharge functions and responsibilities which are necessary, appropriate, or incidental to the efficient and effective provision of the basic services and facilities, such as, but not limited to, public works and infrastructure projects and other facilities, programs and services funded by the national government under the annual General Appropriation Act;

WHEREAS, the City of Mandaluyong, through the City Planning and Development Department intended the utilization of the LGSF for the proposed Construction of Elevated or At-Grade Pedestrian Footpath and Walkway located at Acacia Lane Street, Corner Ortigas Extension St., Barangay Hagdan Bato, City of Mandaluyong;

WHEREAS, in accordance with DBM-Local Budget Circular No. 164, upon the downgrading of the LGSF to the city beneficiary within Metro Manila, and prior to the implementation of the project/program, Mandaluyong City Government is required to enter into a Memorandum of Agreement (MOA) with the Metropolitan Manila Development Authority (MMDA) which is tasked to facilitate coordination activities, technical workshops, assessment of proposals, and consultation meetings with the beneficiary city in providing necessary technical assistance in the validation and enhancement of the submitted plans and other relevant documents;

WHEREAS, in accordance with Sections 22 and 455 of the LGC, the Honorable City Mayor, on behalf of the City Government of Mandaluyong, may upon the prior authorization from the Sangguniang Panlungsod, enter into contracts and represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable City Mayor, Carmelita “Menchie” A. Abalos, to enter into a Memorandum of Agreement with the Metropolitan Manila Development Authority (MMDA) for the Implementation and Utilization of the Green Green Green Program Pursuant to Local Government Support Fund (LGSF)-GAA FY 2025 under Republic Act No. 12116;

RESOLVED FURTHER, to authorize the Honorable City Mayor to execute and perform all acts necessary to give full effect to the MOA;

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the Honorable City Mayor, the MMDA, and other offices concerned for their information and reference.

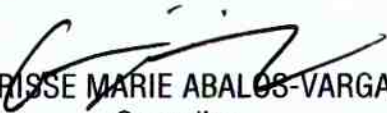

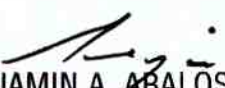

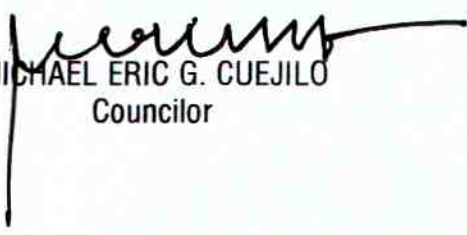
