ORDINANCE NO. 880, S-2022

**AN ORDINANCE APPROVING THE CITY
OF MANDALUYONG'S LOCAL PUBLIC
TRANSPORT ROUTE PLAN AND ITS
IMMEDIATE IMPLEMENTATION**

WHEREAS, by virtue of Section 16 of the General Welfare Clause of Republic Act No. 7160 (1991) or the "Local Government Code of 1991," local government units ("LGU") are granted the authority to exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, through the General Welfare Clause of the Local Government Code ("LGC"), LGUs are mandated to promote the safety of the people within their respective territorial jurisdictions;

WHEREAS, included in the provision of basic services and facilities under Section 17 of the LGC is to ensure the safety and effective management of the LGU's transportation sector and its allied industries;

WHEREAS, in furtherance of the General Welfare Clause of the LGC, it is most crucial to establish an effective and efficient Local Public Transport Route Plan beneficial to all stakeholders;

WHEREAS, the City of Mandaluyong has not only become a highly urbanized city but has long been the center for industrial and commercial developments by the business community, thereby implying a need for reforms in order to meet the challenges and changes inherent to expansion and increased competitiveness;

WHEREAS, the City is aware of and remain committed on its mandate to ensure efficient flow of traffic in the City and safety of all commuters and residents alike; and

WHEREAS, the City Comprehensive Land Use Plan (CLUP) 2017-2032 presents a new Vision Statement for the City of Mandaluyong, reflecting on five pillars-people, natural and built environment, economy and governance:

"A world-class City of God-centered, responsible and resilient society living secured in a well-planned, sustainable and peaceful environment that nurtures inclusive economic growth towards global competence, under a leadership that is visionary, dynamic and pro-active."

NOW, THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Panlungsod of Mandaluyong City, in session duly assembled:

SECTION 1. APPROVAL OF THE LOCAL PUBLIC TRANSPORT ROUTE PLAN - The Local Public Transport Route Plan (LPTRP) 2022 prepared by the Committee/Team on LPTRP and the corresponding recommendations stated therein, are hereby approved.

A copy of the LPTRP 2022 of the City of Mandaluyong is attached and made an integral part of this Ordinance.

SECTION 2. IMPLEMENTING AGENCY/IES - The Traffic and Parking Management Department of Mandaluyong City ("Department") shall be the lead agency in implementing the (i) recommendations of the LPTRP and (ii) provisions and objectives of this Ordinance.

The City Legal Department shall take appropriate action against violators upon the recommendation of the Department for non-compliance with the provisions of this Ordinance.

SECTION 3. INFORMATION DISSEMINATION - The Department shall conduct appropriate information dissemination campaign to ensure that stakeholders are made aware of the contents of the LPTRP and provisions of this Ordinance.

SECTION 4. IMPLEMENTING RULES AND REGULATIONS - The Department, in coordination with the City Legal Department, shall take the lead in the preparation of the Implementing Rules and Regulations within sixty (60) days after approval of this Ordinance.

SECTION 5. SEPARABILITY - If any provision of this Ordinance or the application of such provision is declared unconstitutional or invalid, the remainder of this Ordinance or the application of such provision unaffected by such unconstitutionality and invalidity shall not be affected.

SECTION 6. REPEALING CLAUSE - Any Ordinance or any provision thereof, inconsistent with or contrary to the provisions of this Ordinance is hereby repealed.

SECTION 7. EFFECTIVITY CLAUSE - This Ordinance shall take effect after approval and after fifteen (15) days following its complete posting and publication in a newspaper of general circulation within the City of Mandaluyong.
