RESOLUTION NO. 3775, S-2026

**A RESOLUTION APPROVING AND ADOPTING  
THE LOCAL YOUTH DEVELOPMENT PLAN  
(LYDP) OF THE CITY OF MANDALUYONG  
FOR CALENDAR YEARS 2026-2030**

WHEREAS, Article II, Section 13 of the 1987 Constitution declares that it is the policy of the State to recognize the vital role of the youth in nation-building, and to promote and protect their physical, moral, spiritual, intellectual, and social well-being. It further mandates that the State shall inculcate in the youth patriotism and nationalism, and encourage their active involvement in public and civic affairs;

WHEREAS, Republic Act No. 10742, also known as the Sangguniang Kabataan Reform Act of 2015 (“SK Reform Act of 2015”), ensures broad and multi-sectoral youth participation in governance. Further, Section 23 of the cited law, explicitly provides for the creation of the Local Youth Development Council (“LYDC”) composed of youth and youth-serving organizations in the City, which aims to ensure wide and multi-sectoral youth participation in local governance and shall assist the planning and execution of projects and programs of the Sangguniang Kabataan, and the Federation in all levels;

WHEREAS, in compliance with this mandate, the Local Youth Development Council (“LYDC”) of Mandaluyong City, through its members from various youth-serving sectors and organizations, has formulated and approved a comprehensive Local Youth Development Plan for Calendar Years 2026–2030, outlining priority concerns and corresponding programs, projects, and activities to ensure initiatives are responsive to the needs and aspirations of the youth, and aligned with the Philippine Youth Development Plan (“PYDP”) and the Local Government Unit’s development plans;

WHEREAS, pursuant to Section 8(h) of SK Reform Act of 2015, the Sangguniang Kabataan shall partner with the Local Youth Development Council (“LYDC”) in planning and executing projects and programs of specific advocacies;

WHEREAS, the City Government of Mandaluyong finds it necessary to include the comprehensive 5-year strategic Local Youth Development Plan covering the years 2026-2030 in the Local Development Plan.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, **RESOLVED**, as it hereby **RESOLVES**, to approve and adopt the Local Youth Development Plan (LYDP) of the City of Mandaluyong for Calendar Years 2026-2030.

RESOLVED FURTHER, all Sangguniang Kabataan units in all barangays of the City of Mandaluyong are hereby directed to adopt and utilize the Local Youth Development Plan for Calendar Years 2026-2030 as the primary reference in the formulation, prioritization, planning, implementation, monitoring, and evaluation of youth-related programs, projects, activities, or their respective Programs, Projects, and Activities (PPAs), as well as in the preparation of their Annual Barangay Youth Investment Program (ABYIP) and corresponding budget allocations, to promote coherence, efficiency, and impact in youth development efforts.

RESOLVED FURTHER, the Local Youth Development Council, in coordination with the Sangguniang Kabataan Federation and the concerned offices of the City Government, shall assist in the implementation, monitoring, and periodic evaluation of the programs and initiatives identified in the Local Youth Development Plan.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to the Office of the City Mayor, the Local Youth Development Council, the Sangguniang Kabataan Federation of Mandaluyong City, Liga ng mga Barangay, and all other concerned departments, agencies, and offices of the Mandaluyong City Government for their information, guidance, and appropriate action.

RESOLVED FINALLY, that the subject Local Youth Development Plan ("LYDP") of the City of Mandaluyong for Calendar Years 2026-2030 shall be made an integral part hereof for approval.
