A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR  
NEPTALI M. GONZALES II ENTER INTO A SISTER CITY  
AGREEMENT BETWEEN THE CITY OF VIGAN,  
ILOCOS SUR AND THE CITY OF MANDALUYONG  
AS PER INVITATION OF THE SANGGUNIANG  
PANLUNGSOD OF VIGAN VIA ITS RESOLUTION NO. 38, S-2006

WHEREAS, the Sangguniang Panlungsod of Vigan, Ilocos Sur, via its Resolution No. 38, S-2006, is extending an invitation to the City of Mandaluyong to become a Sister City of Vigan;

WHEREAS, according to this Resolution No. 38, S-2006 "it is the desire of the City Government of Vigan to have the City of Mandaluyong as one of its sister cities, hence, the necessity of forging a sisterhood relationship with the City of Mandaluyong to enhance and encourage cooperation for the development of programs of both cities and to pave the way for the sharing of ideas and experiences on local governance, cooperation and exchanges on economic, education, cultural and tourism aspects";

WHEREAS, such sisterhood relationship between these two cities can be reciprocally beneficial, especially in terms of heritage conservation and environmental protection considering that Vigan is a World Heritage Site; and


WHEREAS, in view whereof, the Sangguniang Panlungsod of Mandaluyong hereby endorses to the Honorable City Mayor NEPTALI M. GONZALES II to accept the invitation of the Sangguniang Panlungsod of Vigan for Mandaluyong to become a Sister City of Vigan.

NOW, THEREFORE, BE IT RESOLVED by the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to recommend that Honorable City Mayor NEPTALI M. GONZALES II enter into a Sister City Agreement between the City of Vigan, Ilocos Sur and the City of Mandaluyong, as per invitation of the Sangguniang Panlungsod of Vigan via its Resolution No. 38, S-2006.

RESOLVED, FURTHER, that Honorable City Mayor FERDINAND C. MEDINA, Honorable City Vice Mayor FRANCISCO P. RANCHES, JR., and the Sangguniang Panlungsod Honorable Members of the City of Vigan, Ilocos Sur each be furnished a copy of this Resolution.


