ORDINANCE NO. 441, S-2009

AN ORDINANCE RENAMING J. LUNA EXTENSION,
A PORTION OF THE MAIN J. LUNA STREET,
TO ARMAND V. FABELLA STREET

EXPLANATORY NOTES

WHEREAS, the late DR. ARMAND V. FABELLA who died on November 27, 2008 is the son of the late DON VICENTE K. FABELLA, an illustrious leader, educator, philanthropist and a great man of honor and competence;

WHEREAS, the late DR. ARMAND V. FABELLA's sterling contribution in the field of economics, finance, banking and education and as a cabinet man of former Presidents of the Republic of the Philippines cannot just be enumerated in brief for the reason that his achievements seemed to be *primus inter pares*;

WHEREAS, it would be of better significance to enumerate his valuable achievements, contributions and brilliant stewardship during his lifetime in order to satisfy and address the curiosity of fellow Mandaleños and the Filipino people how this great man of letters and wizard of economics and financial institution and as an icon in the field of education deserves this kind of recognition and appreciation by the Sangguniang Panlungsod, thus, here and there, to wit:

- DR. ARMAND V. FABELLA served as Secretary of Education, Culture and Sports; Chairman, Presidential Commission on Reorganization; Consultant, Central Bank of the Philippines; Chairman, Board of Directors–United Coconut Planters Bank; Chairman, Board of Trustees–Private Education Retirement and Annuity Association (PERAA) and Chairman, Board of Trustees–Jose Rizal University;
- DR. ARMAND V. FABELLA, an awardee of the Ten Outstanding Young Men; Eisenhower Fellow to the United States; Doctor in Economics (Honoris Causa) Philippine Women's University; Presidential Citation; Philippine Association of Colleges and Universities (PACU) "Man of the Year"; Doctor of Educational Management (Honoris Causa) Emilio Aguinaldo College; Doctor of Education (Honoris Causa) Misamis University; Presidential Medal of Merit and Mandaluyong City "Tatlong Bayani Award";

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of Mandaluyong, in session assembled, upon motion duly seconded that:

SECTION 1. This is An Ordinance Renaming J. Luna Extension to Armand V. Fabella Street;

SECTION 2. It is hereby ordained by this Sangguniang Panlungsod that the present J. Luna Street Extension, specifically bounded by Shaw Boulevard up to corner P. Martinez and J. Luna Street, be renamed Armand V. Fabella Street.

J. Luna Street starts between the streets of Pinagtipunan and 29 de Agosto and a small portion of which ends between V. Fabella and San Clemente Street.

SECTION 3. The following agencies shall each be furnished a copy of this Ordinance:

- a. The National Historical Institute (NHI) for its information and record purposes;
- b. The Mandaluyong City Planning and Development Office for its information and corresponding change and annotation in the Official Political Map of the City of Mandaluyong;
- c. The Mandaluyong City Engineering Department for its information and corresponding change of the street sign to Armand V. Fabella Street;
- d. Philippine Postal Corporation (Mandaluyong Central Post Office);
- e. Department of Transportation and Communications;
- f. Other concerned local government offices or agencies.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately after its approval and publication at least once in a newspaper of general circulation in Metro Manila.

ENACTED on this 16th day of November, 2009 in the City of Mandaluyong.


