ORDINANCE NO. 140, S-1994

AN ORDINANCE RENAMING DONA PILAR
ELEMENTARY SCHOOL TO PAARALANG
ELEMENTARYANG DONA PILAR C.
GONZAGA ELEMENTARY SCHOOL.

EXPLANATORY NOTES

WHEREAS, Doña Pilar Elementary School at Gonzaga Street, City of Mandaluyong has been named after Pilar O. Vda. de Gonzaga in recognition of the donations of a land now housing a public school and at present is benefiting so many grade school children;

WHEREAS, in a meeting held by the Parents Teachers Association (PTA) of the school on December 01, 1993, presided by its President, Mr. Reynaldo Molina, it was unanimously approved and resolved to request the City Council of Mandaluyong to change the name from Doña Pilar Elementary School to Doña Pilar Gonzaga Elementary School;

WHEREAS, the City of Mandaluyong School Board, acting on above resolution, unanimously approved on June 24, 1994 indorsing to the City Council the same for proper study and appropriate action;

WHEREAS, Section 99 (d) of the Local Government Code recognizes the recommendatory privilege of the school board on such changing of names of public schools;

WHEREAS, Section 13, (4) the Sanggunian of highly urbanized cities may in consultation with the Philippine Historical Commission change the name of "public elementary, secondary or vocational or technical schools, community colleges and non-chartered cities";

WHEREAS, this decision has been based purely on the idea that such change will truly serve as a living memory for the deceased-donor and likewise may be considered as an effective way of expressing the sincerest gratitude and deepest appreciation to the family.

ORDINANCE NO. 140, S-1994

BE IT ENACTED by the Sangguniang Panlungsod of Mandaluyong, in session assembled, upon motion duly seconded, that;

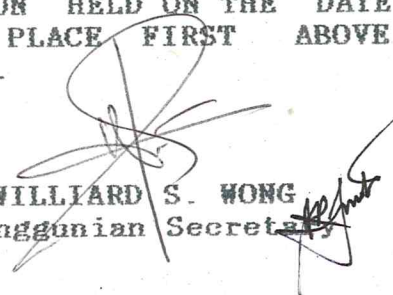
Section 1. The name of Doña Pilar Elementary School located at M. Gonzaga Street, Hagdang Bato Itaas, City of Mandaluyong shall, henceforth, be named PAARALANG ELEMENTARYANG DONA PILAR C. GONZAGA.

Section 2. Let copies of this Ordinance be forwarded to National Historical Commission, Congress of the Philippines and Secretary of Education, Sports and Culture.

Section 3. This Ordinance shall take effect upon approval.

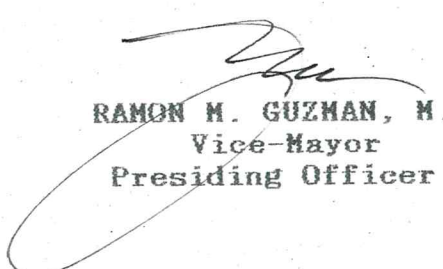
ENACTED on this 15th day of September, 1994, in the City of Mandaluyong.

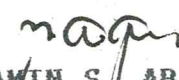
