ORDINANCE NO. 900, S-2022

AN ORDINANCE ESTABLISHING THE MANDALUYONG CITY HEALTH DEPARTMENT WAREHOUSE AND DISPENSING FACILITY LOCATED AT THE 2ND FLOOR OF THE BOC BUILDING, MAYSILO CIRCLE, BARANGAY PLAINVIEW, MANDALUYONG CITY

WHEREAS, Section 17 of Republic Act No. 7160 or the Local Government Code of 1991 provides that local government units shall endeavor to be self-reliant and continue exercising their powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities as are necessary, appropriate, or incidental to the efficient and effective provisions of the basic services and facilities under the Code;

WHEREAS, the City Health Department Warehouse shall serve as a storage facility for essential medicines and other pharmaceutical and office commodities and equipment under the ownership of the local government of Mandaluyong City;

WHEREAS, there is a need to formally establish the same through the enactment of an Ordinance, a requirement for the application of a License to Operate in relation to the Re-engineering of System and Procedures of Republic Act No. 9485 and as indicated in Administrative Order No. 2016-0003 of the Department of Health (DOH).

NOW, THEREFORE, be it ordained by the City Council of Mandaluyong, in session assembled, THAT:

**SECTION 1. ESTABLISHMENT OF THE CITY HEALTH DEPARTMENT WAREHOUSE.** – The Mandaluyong City Health Department Warehouse, located at the 2nd floor of the BOC Building, Maysilo Circle, Brgy. Plainview, Mandaluyong City, is hereby established to serve as a storage facility of medicines and other pharmaceutical commodities and equipment.

**SECTION 2. PURPOSE.** - A single and unified facility in the City shall ensure the safe, quality, efficacy and/or purity of medicines as well as the good condition of medical equipment and supplies.

**SECTION 3. SCOPE OF SERVICE.** - The warehouse shall be responsible for the storage of medical equipment and supplies at the disposal of the City Health Department. Likewise, it shall be responsible for the dispensing and storage of pharmaceutical products for distribution to various health centers, lying-in clinics, social hygiene and sundown clinics, and clinical laboratories in Mandaluyong City.

**SECTION 4. SUPERVISION AND CONTROL.** - The operation of the warehouse shall be done under the supervision and control of the City Health Department. It shall ensure that a licensed pharmacist shall directly control and supervise the procurement, storage, dispensing and distribution of pharmaceutical products stored in the Warehouse, in compliance with Republic Act No. 10918 or the Philippine Pharmacy Act.

SECTION 6. SEPARABILITY CLAUSE. - If for any reason or reasons, any part or provision of this Executive Order shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE. - Any ordinance or provisions thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed and/or modified accordingly.


SECTION 8. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval by the City Council.
