RESOLUTION NO. 3794, S-2026

A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR, HON. CARMELITA A. ABALOS, TO SIGN AND EXECUTE A DEED OF DONATION AND TO ACCEPT, ON BEHALF OF THE CITY GOVERNMENT OF MANDALUYONG, THE DONATION OF TOOLKITS AND TRAINING EQUIPMENT FROM THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) - NATIONAL CAPITAL REGION (NCR)

WHEREAS, the Technical Education and Skills Development Authority (TESDA), pursuant to its mandate under Republic Act No. 7796, otherwise known as the "TESDA Act of 1994," is tasked to provide relevant, accessible, high-quality, and efficient technical education and skills development programs for the middle-level workforce;

WHEREAS, as part of its programs and initiatives, TESDA-National Capital Region (NCR) has offered to donate various toolkits intended to support skills training, livelihood development, and capacity-building programs for the benefit of the constituents of the City of Mandaluyong;

WHEREAS, the acceptance of said donation will greatly enhance the City Government's capability in implementing technical-vocational education programs, livelihood projects, and other community-based development initiatives through the Mandaluyong Manpower and Technical-Vocational Training Center;

WHEREAS, the donation requires the execution of a Deed of Donation between TESDA and the City Government of Mandaluyong, stipulating the terms and conditions of the transfer and acceptance of the said toolkits;

WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Chief Executive requires the authorization from the Sangguniang Panlungsod to enter into contracts, agreements, and similar instruments on behalf of the local government unit, hence, this Resolution.

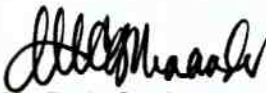
NOW, THEREFORE, on a motion duly seconded, be it RESOLVED, as it is hereby RESOLVED, to authorize the City Mayor, Hon. Carmelita A. Abalos, to sign and execute a Deed of Donation and to accept, on behalf of the City Government of Mandaluyong, the donation of toolkits and training equipment from the Technical Education and Skills Development Authority (TESDA)-National Capital Region (NCR).

RESOLVED FURTHER, that the donated toolkits and training equipment shall be under the safekeeping and maintenance of the MMTVTC and shall be utilized exclusively by the training and livelihood support for community beneficiaries under the programs of the Mandaluyong Manpower and Technical-Vocational Training Center (MMTVTC) and shall not be sold, transferred, or disposed of without the prior written consent of TESDA-NCR;

RESOLVED FURTHER, that a copy of this Resolution be furnished to TESDA-NCR, MMTVTC, and all other offices concerned for their information and appropriate action.

ADOPTED on this 11th day of May 2026, in the City of Mandaluyong.

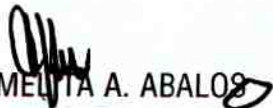
