ORDINANCE NO. 889, S-2022

**AN ORDINANCE AMENDING SECTION 2 OF
ORDINANCE NO. 859, S-2021 FIXING THE
RATE OF TRICYCLE FARE ESPECIALLY FOR
ONE PASSENGER ONLY OR THOSE
CONSIDERED AS A "SPECIAL TRIP"**

WHEREAS, on November 15, 2021, the Sangguniang Panlungsod of Mandaluyong enacted Ordinance No. 859, S-2021 entitled "An Ordinance Temporarily Suspending the Effectivity of Sections 1, 3, and 4 Letter A of Ordinance No. 779, S-2020 Entitled: An Ordinance Establishing a Temporary Minimum Fare of Twenty Pesos (P20.00) in the Duration of the Modified Enhanced Community Quarantine (MECQ), General Community Quarantine (GCQ), Modified General Community Quarantine (MGCQ) or Other Community Quarantine as may be imposed by the National Government in the City of Mandaluyong and Prescribing Guidelines in the Operations and Conduct of Tricycles under the "New Normal" Complying to the Safety Transport Protocols of the Inter-Agency Task Force (IATF);

WHEREAS, Section 2 of Ordinance No. 859, S-2021 prescribes the minimum fare per passenger per trip in the amount of Eight Pesos (P8.00) plus One Peso (P1.00) per kilometer in excess of one (1) Kilometer distance;

WHEREAS, recently, the association of operators and drivers of tricycles in Mandaluyong City clamored for the amendment of the foregoing Section of the said Ordinance to specifically state therein the amount of tricycle fare for one passenger only or those considered as a "special trip";

WHEREAS, there is also a need to increase the minimum tricycle fare considering that it was in Year 2008 or almost fourteen years since the increase in tricycle fare was last allowed and implemented not to mention the current rising cost in fuel;

WHEREAS, there is a need to amend Section 2 of Ordinance No. 859, S-2021 to fix the amount of tricycle fare especially for one passenger only or those considered as a "special trip".

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Mandaluyong, in session assembled:

SECTION 1. Section 2 of Ordinance No. 859, S-2021 is hereby amended to read as follows:

Note: Additional Php 1.00 per succeeding kilometer from terminal to drop off point within their prescribed route/zone.

SECTION 2. All tricycle drivers/operators should post or make known to the riding public the regular, and the discounted fare of the privileged sectors and the necessity of presenting their identification card for the availment of discount for students, persons with disabilities and senior citizens.

SECTION 3. The City Tricycle Regulatory Office (CTRO) shall issue an official Tricycle Fare Matrix sticker to be given to all TODAs, which the tricycle drivers must pos/attach to the inside portion of the tricycle's side car for the passengers' reference.

The Tricycle Fare Matrix as mentioned under Section 1 hereof shall be used by all TODAs registered in Mandaluyong City Tricycle Regulatory Office.

SECTION 4. All Ordinances and Resolutions or any part thereof which are inconsistent with the foregoing provision are hereby repealed or modified accordingly.

SECTION 5. If any provision of this Ordinance is determined to be invalid, illegal or unenforceable, its remaining provisions shall remain in full force as though this Ordinance did not originally include such invalid, illegal or unenforceable provision.

SECTION 6. Let copy of this Ordinance be furnished the Office of the City Mayor, Mandaluyong City Police Station and those PNP personnel stationed in Mandaluyong City, Liga ng mga Barangay, City Traffic and Parking Management Department, City Ordinance and Enforcement Division (COED), City Business Permit and Licensing Department, Anti-Vice Division, Public Order and Safety Division, Mayor's Action Command (MAC) and other offices concerned for their information, guidance and reference.

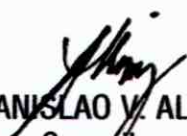

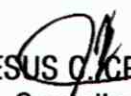
