A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELITA A. ABALOS TO ENTER INTO, SIGN AND ACCEPT THE DEED OF DONATION WITH THE METRO MANILA DEVELOPMENT AUTHORITY ON THEIR DONATION OF RADIO EQUIPMENT TO MANDALUYONG CITY

WHEREAS, the Metro Manila Development Authority, a public corporation duly organized under Presidential Decree No. 824, as amended by Republic Act No. 7924, recognizes and supports the City Government of Mandaluyong's task of responding and addressing emergencies and calamities, both natural and man-made;

WHEREAS, in furtherance of such fervent support to the City Government and in order to sustain the City Government's continuing disaster risk reduction and management efforts, the Metro Manila Development Authority hereby assigns and donates its personal properties consisting of the following:

- a.) One (1) set of Hytera Base Radio Model MD 788G (SN: 18911A0144)
- b.) One (1) set of Hytera Power Supply Model PS2022 (SN: 18518E2143)
- c.) One (1) set of Back-up Battery
- d.) One (1) set of Automatic Voltage Regulator
- e.) One (1) set of Omni Antenna Diamond Model BC200L
- f.) Fifty (50) meters Co-axial Cable with Connectors
- g.) One (1) set Antenna Pole

WHEREAS, the City Government of Mandaluyong willingly accepts the donation of the foregoing enumerated radio equipment as it will greatly augment its disaster risk reduction and management efforts and capabilities, thereby giving better public service to its constituents;

WHEREAS, a Deed of Donation has been drafted to cover this donation of radio equipment by the Metro Manila Development Authority to the City Government of Mandaluyong;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Deed of Donation that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable City Mayor CARMELITA A. ABALOS to enter into and sign the Deed of Donation with the Metro Manila Development Authority and accept the latter's donation of radio equipment herein enumerated, for the City Government of Mandaluyong.

RESOLVED, that copy of this Resolution be furnished to the Office of the City Mayor, City Administrator, City Disaster Risk Reduction and Management Office and the City Accounting Department for their information and guidance.

This Resolution shall take effect immediately upon its approval.

ADOPTED on this 27th day of June 2022, in the City of Mandaluyong.


