RESOLUTION NO. 3226, S-2023

A RESOLUTION MANDATING THE CODIFICATION OF THE REGULATORY ORDINANCES OF THE CITY OF MANDALUYONG, CREATING THE TECHNICAL WORKING GROUP FOR THE PURPOSE AND ALLOCATING FUNDS THEREOF

WHEREAS, of equal importance to the enactment of city ordinances is its proper and adequate dissemination to the general public to serve well their need to know and comply with all city laws to the end that we may live in an orderly and peaceful city;

WHEREAS, out of that realization, and to provide an adequate tool to aid in the effective and efficient enforcement and implementation of city ordinances, the Sangguniang Panlungsod of the City published "The Book of Ordinances (1988-2005), which served as a very handy reference for all those involved in public service: the City's Barangay officials and their Bantay Bayan, the members of the Philippine National Police – Mandaluyong Office, the various enforcing offices and units of the City, the office of the City Prosecutor and the Courts;

WHEREAS, it was very gratifying that "The Book of Ordinances" also became a source of reference for the other local government units from the islands of Luzon, Visayas, and Mindanao of the country, who have secured copies of the Book;

WHEREAS, there is a fervent request for the codification of city ordinances from the Barangay Officials of the City, the members of the Philippine National Police – Mandaluyong Office, the City's enforcing offices and units, including the Office of the City Prosecutors, whose representative in the Peace and Order Council was the first to voice out the request, as "The Book of Ordinances" has become a very effective tool that aided them in the performance of their duties.

NOW THEREFORE, the 12th Council of the City of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to mandate the codification of the regulatory ordinances of the City and creating for the purpose the Technical Working Group to be composed of the following:


This Resolution shall take effect immediately upon approval.
