RESOLUTION NO. 3262, S-2023



A RESOLUTION AUTHORIZING THE OWNERS/OPERATORS OF THEATER AND CINEMA HOUSES IN MANDALUYONG CITY TO MAKE PSORIASIS PHILIPPINES (PSORPHIL) AS THE BENEFICIARY OF THE ONE (1) PESO CINEMA SURCHARGE FROM MAY 1, 2023 TO MAY 31, 2023

WHEREAS, once again, the Psoriasis Philippines (PsorPhil), thru a Resolution is requesting the Honorable Mandaluyong City Mayor Benjamin S. Abalos, to pass a Sangguniang Panlungsod Resolution authorizing the theaters and cinema houses in Mandaluyong City to make PsorPhil as the beneficiary of the One (1) Peso Cinema Surcharge from May 1, 2023 to May 31, 2023;

WHEREAS, from 2013 up to 2019, the City of Mandaluyong has been supporting the Psoriasis Philippines (PsorPhil) by making them one of the beneficiaries in the One (1) Peso Cinema Surcharge. Due to the COVID-19 pandemic, the support was discontinued as most of the cinemas were forced to close. Now that we are gradually attaining normalcy and cinemas are being allowed to operate, this tradition in supporting PsorPhil must remain and continue;

WHEREAS, the proceeds shall go to the Psoriasis Philippines (PsorPhil) to raise awareness about psoriasis, its prevention, management of the condition, misconceptions about it, stigma and to discourage discrimination against Filipinos living with psoriatic disease;

WHEREAS, since the request is for a noble purpose, which is worthy of favorable consideration, the Sangguniang Panlungsod of Mandaluyong, by virtue of the powers vested in it by law, has decided to pass this Resolution.

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Panlungsod in session assembled that:

SECTION 1. The owners/operators of theaters or cinema houses in Mandaluyong City are hereby authorized to make Psoriasis Philippines (PsorPhil) as the beneficiary of the One (1) Peso Cinema Surcharge from May 1, 2023 to May 31, 2023;


SECTION 2. Within sixty (60) days from the end of the collection period, the owners/operators of theaters or cinema houses shall remit the amount collected directly to the Psoriasis Philippines (PsorPhil). Said amount shall be exempt from payment of amusement tax;

SECTION 3. The Psoriasis Philippines (PsorPhil) is hereby required to submit a report of the remittance within ten (10) days from receipt thereof to the Office of the City Mayor, copy furnished the Sangguniang Panlungsod of Mandaluyong;

SECTION 4. Let a copy of this Resolution be furnished to the Office of the City Mayor, City Treasurer and the Psoriasis Philippines (PsorPhil), with the latter providing a copy to the theater owners/operators for their information and guidance.


