RESOLUTION NO. 3275, S-2023

**A RESOLUTION ADOPTING AND APPROVING THE
MANDALUYONG CITY LOCAL ANTI-DRUG PLAN
OF ACTION (LADPA) FOR THE YEAR 2023-2025**

WHEREAS, under DILG Memorandum Circular No. 2017-141 "Guidelines on the Formulation of the Local Anti-Drug Plan of Action (LADPA) and Barangay Anti-Drug Plan of Action", it mandates the formulation and implementation of the three-year Local Anti-Drug Plan of Action;

WHEREAS, DILG Memorandum Circular No. 2017-64, Compliance to Peace and Order and Anti-Illegal Drug Related issuances directs the "Formulation of Peace and Order Plan and ADAC Plan of Action";

WHEREAS, Section 51 of R.A. No. 9155, otherwise known as the "Comprehensive Dangerous Drugs Act of 2002", provides that the "local government units shall appropriate a substantial portion of their respective annual budgets to assist in or enhance the enforcement of said Act giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents";

WHEREAS, the Mandaluyong Anti-Drug Abuse Council (MADAC) – Technical Working Group developed the Mandaluyong City Local Anti-Drug Plan of Action, which was approved by the Council on March 23, 2023, following a series of LADPA Planning, Orientation, Stakeholders Workshop, and inter-agency meetings;

WHEREAS, the Mandaluyong City Local Anti-Drug Plan of Action for the Year 2023- 2025 will serve as the local plan containing the list of programs, projects and activities for implementation to fight illegal drugs and to address existing illegal drug issues arising in the City of Mandaluyong.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to adopt and approve the Mandaluyong City Local Anti-Drug Plan of Action (LADPA) for the Year 2023-2025.


ADOPTED on this 22nd day of May 2023, in the City of Mandaluyong.


