A RESOLUTION URGING CONTRACTORS OF BUILDINGS AND OWNERS OF VACANT LOTS LOCATED IN THE CITY OF MANDALUYONG TO FENCE THEIR SURROUNDINGS AND MAINTAIN THE CLEANLINESS AND PLEASING LOOK OF THEIR FENCE IN SUPPORT OF THE CLEANLINESS AND BEAUTIFICATION PROGRAM OF THE CITY

WHEREAS, very commendable are the support and cooperation being shown by the Mandaleños on the "Cleanliness and Beautification Program" of the City of Mandaluyong;

WHEREAS, the support and cooperation are visibly manifested in the Mandaleños untiring efforts at maintaining their respective surroundings always clean and pleasing to the eye; while the City's hardworking street sweepers, unmindful of the scorching heat of the sun and sometimes the heavy downfall of the rain maintain the streets, sidewalks and other public places of the City free from litters and garbage;

WHEREAS, these collaboration between the Mandaleños and the City in keeping Mandaluyong environment-friendly mirrors the aspiration of the Mandaleños to live in a community that is conducive to healthy living;

WHEREAS, this "Cleanliness and Beautification Program" of Mandaluyong City has to be sustained and in consonance thereto, there is a need to appeal to contractors of buildings and owners of vacant lots, located in the City of Mandaluyong, to fence their surroundings and maintain the cleanliness and pleasing look of the same in support of the above-cited program.

NOW THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED as it is hereby RESOLVES, to urge contractors of buildings and owners of vacant lots located in the City, to fence their surroundings and maintain the cleanliness and pleasing look of the same in support of the City's "Cleanliness and Beautification Program".

RESOLVED FURTHER, to task the Office of the City Engineer to seek the cooperation of all contractors of buildings to the cause of this Resolution.

FURTHER RESOLVED, to furnish all the Punong Barangays of the City copies of this Resolution as they are hereby enjoined to monitor compliance to the Resolution by contractors of buildings and to make the appeal to owners of vacant lots in their respective areas of jurisdiction for their support to the program.
