**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE SCHOLARSHIP SERVICE CONTRACTS BETWEEN THE DEPARTMENT OF HEALTH AND MS. EDITHA N. BALATBAT AND MS JUANITA M. ESCALANTE, AS THEIR GUARANTOR**

WHEREAS, the Health Human Resource Development Bureau of the Department of Health, in partnership with the University of the Philippines College of Nursing, will run its 2nd batch of the scholarship program on the Leadership Development Course for Midwives from June 15, 2023 to July 10, 2023;

WHEREAS, the City Government of Mandaluyong fully support this program of the DOH wherein the participants will be equipped with new knowledge on leadership development;

WHEREAS, this program has been specifically designed for midwives in the public health setting such as midwives in the rural and urban health centers, or midwife supervisors;

WHEREAS, the Department of Health provided the Scholarship Service Contract between them, grantees and guarantor which contains the terms and conditions relating to the conduct of the program;

WHEREAS, the City Health Department formally endorsed Ms. Editha N. Balatbat and Ms. Juanita M. Escalante to be allowed to attend the program within the provided duration;

WHEREAS, Department of Health requires the City Government of Mandaluyong to be the guarantor of the grantees, Ms. Editha N. Balatbat and Ms. Juanita M. Escalante;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the SCHOLARSHIP SERVICE CONTRACTS for the Leadership Development Course for Midwives of the University of the Philippines, Manila, under the Department of Health-Local Scholarship Program between the Department of Health, Ms. Editha N. Balatbat, Ms. Juanita M. Escalante and the City Government of Mandaluyong as their guarantor.
