RESOLUTION NO. 3304, S-2023

**RESOLUTION AUTHORIZING THE ISSUANCE OF
LICENSE TO OPERATE COCKFIGHTING
ACTIVITIES TO MANDALUYONG COCKPIT
ARENA WITHIN THE CITY OF MANDALUYONG**

WHEREAS, Section 458 (a)(3)(v) of Republic Act 7160 or the Local Government Code provides that the Sangguniang Panlungsod may authorize and license the establishment, operation and maintenance of cockpits, and regulate the cockfighting and commercial breeding of gamecocks;

WHEREAS, in his letter dated June 07, 2023, the new owner of Mandaluyong Cockpit Arena, RQP Resources Development Corporation represented by Ms. Roselle G. Pineda, thru Mr. Erick Geoffrey P. Ocampo, Corporate Secretary of RQP Resources Development Corporation, applied for the issuance of a license to operate cockfighting in the Mandaluyong Cockpit Arena;

WHEREAS, the issuance of license to this business venture shall mean continued remittance of taxes, fees and other charges beneficial and advantageous to the City, provided that existing rules and regulations should not be prejudiced;


WHEREAS, the opening of cockfighting activities in the Mandaluyong Cockpit Arena merits the consideration of the Sangguniang Panlungsod as it will greatly help this City not only in addressing unemployment but also in contributing to the City's revenue in the form of taxes, enhancing eco-business and local tourism and promoting entertainment, subject to existing rules and regulations and adhering to strict observance of standard health protocols;


WHEREAS, unless sooner revoked or cancelled, this authority shall be valid for a period of one (1) year with the option on the part of grantee to renew the same annually and subject to the approval of the Sangguniang Panlungsod.


