RESOLUTION NO. 3305, S-2023



A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT - NATIONAL CAPITAL REGION AND THE CITY GOVERNMENT OF MANDALUYONG FOR THE CONDUCT OF THE JOBSTART PHILIPPINES PROGRAM IN MANDALUYONG CITY

WHEREAS, in Section 17 of the Local Government Code or RA 7160, it is mandated that a job placement system is a basic service a local government unit could provide its inhabitants;

WHEREAS, the Public Employment Service Offices (PESOs), maintained largely by Local Government Units (LGUs) and linked to the Field, Regional and Central Offices of the Department of Labor and Employment (DOLE) for coordination and technical supervision, and shall constitute the national employment service network, as prescribed under RA 8759 or the Public Employment Service Office Act of 1999;

WHEREAS, the DOLE has considered Mandaluyong City to be part of its flagship program JobStart Philippines, which was institutionalized under RA 10869 or the JobStart Act;

WHEREAS, a Memorandum of Agreement has been drafted to cover the collaboration of the DOLE-NCR Region, Bureau of Local Employment and the City Government of Mandaluyong in the roll out of the JobStart Philippines program in Mandaluyong City;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that will govern the parties' complementary rights and obligations, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, authorizing the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Memorandum of Agreement with the Department of Labor and Employment - National Capital Region and the City Government of Mandaluyong for the conduct of the JobStart Philippines program in Mandaluyong City.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, City Administrator, Public Employment Services Department, Department of Labor and Employment – National Capital Region and the Bureau of Local Employment for their information and guidance.
