RESOLUTION NO. 3354, S-2023

RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2023 TO INCLUDE THE PROGRAMS, PROJECTS AND ACTIVITIES (PPA) OF THE MANDALUYONG CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (CDRRMO) UNDER MAINTENANCE & OTHER OPERATING EXPENSES (MOOE) TO BE COVERED BY SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2023

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the Year 2022;

WHEREAS, due to the exigencies of public service and to maximize the utilization of funds before the year ends, there are various programs, projects and activities (PPA), specifically procurement of hygiene kits, acquisition of relief goods, and procurement of various medical emergency response supplies, that need to be adopted, funded, and implemented by the CDRRMO as part of its disaster response efforts;

WHEREAS, the sources of funds for these various PPA have been identified and will be appropriated through Supplemental Budget No. 4 for CY 2023;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original AIP to include those PPA of the CDRRMO by the Supplemental Budget No. 4 for CY 2023.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to approve, ratify, and confirm as the Supplemental Annual Investment Program (AIP) for Calendar Year 2023 of the City Government of Mandaluyong to include those PPAs of the CDRRMO under MOOE to be covered by the Supplemental Budget No. 4 for Calendar Year 2023.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Office of the City Mayor, City Planning and Development Department, City Budget Department, City Accounting Department, City Treasurer's Department, and CDRRMO for their information, guidance and reference.
