RESOLUTION NO. 3355, S-2023

RESOLUTION AUTHORIZING THE CITY BUDGET OFFICER, MR. ORLANDO F. FUMERA, JR., AS THE OVERALL CHAIRPERSON/PERSON-IN-CHARGE OF THE PREPARATION, CELEBRATION AND CONDUCT OF THE HOLIDAY SEASON FESTIVITY KNOWN AS "PASKUHAN SA TIGER CITY 2023" AND TO SIGN, EXECUTE AND ENTER INTO AGREEMENTS REGARDING ALL PROJECTS, PROGRAMS AND ACTIVITIES RELATED THERETO

WHEREAS, Paskuhan sa Tiger City 2023 is one of the highly anticipated yuletide activities in the City and one of its popular attractions is the Christmas Bazaar where shoppers troop, looking for good bargains and do sight-seeing;

WHEREAS, the celebration of "Paskuhan sa Tiger City 2023" for the benefit of all Mandaleños will commence on November 20, 2023 and will end on January 3, 2024 (43 days/nights);

WHEREAS, the City recognizes the Christmas Bazaar as one of the creative ways of promoting the City's businesses and dynamic tourism, and an effective way to generate employment and income for resident micro and small entrepreneurs. The Paskuhan sa Tiger City 2023 will be the best avenue to showcase entrepreneurial spirit;

WHEREAS, the City is now in the thick of preparations for the Paskuhan sa Tiger City 2023, and it will be spearheaded by MR. ORLANDO F. FUMERA, JR., City Budget Officer, who shall perform the following:

1. Initiate the processing of the Bazaar Exhibitors' applications and issue ORDERS OF PAYMENT in the total amount of FIFTY THOUSAND PESOS (Php 50,000.00) only broken down as follows:

Regular Booth Rental	₱ 49,150.00
Special Business Permit	₱ 850.00
Total	₱ 50,000.00

*All Payments shall go directly to the Office of the City Treasurer.

2. Take lead and identify slots/booths with special cases and come up with corresponding price estimates for such;
3. Seek support and/or sponsorship payable to the City Government of Mandaluyong (in case of financial support) from our friends in private enterprises in the City of Mandaluyong;
4. Oversee entertainment and nightly programs including carnival rides (if any) and wholesome games for children;

5. Coordinate with all departments/agencies of the City Government, if and when deemed proper and necessary;
6. Formulate policies and or guidelines to ensure the orderly implementation of the Paskuhan sa Tiger City 2023;
7. And all other duties as may be deemed necessary and appropriate to ensure the complete success of the 43-day event.
8. Facilitate processing of payments, payrolls if and when applicable and necessary.

WHEREAS, sub-leasing shall not be allowed unless for a valid reason and with the written conformity of the Office of the City Mayor, thru City Executive Secretary VICTOR E. VICTORIA;

WHEREAS, only bonafide residents of the City of Mandaluyong shall be awarded one (1) slot each only.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the City Budget Officer, Mr. Orlando F. Fumera, Jr., as the overall chairperson/person-in-charge of the preparation, celebration and conduct of the holiday season festivity known as "Paskuhan sa Tiger City 2023" and to sign, execute and enter into agreements regarding all projects, programs and activities related thereto.

ADOPTED on this 26th day of October 2023, in the City of Mandaluyong.


