**RESOLUTION NO. 3357, S-2023**

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT AND OTHER RELEVANT DOCUMENTS TO BE EXECUTED BY THE CITY GOVERNMENT OF MANDALUYONG, MELCO RESORTS (PHILIPPINES) FOUNDATION CORPORATION, AND MELCO RESORTS LEISURE (PHP) CORPORATION RELATIVE TO THE PROVISION OF FINANCIAL ASSISTANCE AMOUNTING TO TWENTY MILLION PESOS (PHP20,000,000.00) FOR THE PURCHASE OF SEVERAL VACCINES TO BE DISTRIBUTED AND ADMINISTERED WITHIN THE CITY OF MANDALUYONG

WHEREAS, Melco Resorts (Philippines) Foundation ("Foundation") is an entity incorporated and registered with the Philippine Securities and Exchange Commission on 19 February 2014;

WHEREAS, Melco Resorts Leisure (PHP) Corporation, a connected entity of the Foundation incorporated by and comprising of several casinos in the country, is obligated, under the terms of its Gaming License with the Philippine Amusement and Gaming Corporation ("PAGCOR"), to regularly set aside funds for the Foundation's operation and implementation of specialized projects for the continuous effectivity of the said License, particularly on the fields of Cultural Heritage, Education, and Environment and Health;

WHEREAS, as part of its compliance with the said mandate, the Foundation identified the City of Mandaluyong as a viable partner in its efforts to implement and fund projects geared towards the development of health programs;

WHEREAS, for the afore-cited purpose, the Foundation expressed its willingness and capability to partner with the City of Mandaluyong for the purchase of several vaccines for the benefit of the City's constituents ("Project") with an allocated amount of Pesos: Twenty Million (Php20,000,000.00) under the following disbursement terms, to wit:

WHEREAS, as evidence of the same, PAGCOR, in its letter dated 19 October 2023, advised the Foundation of the issuance of the corresponding Project Concept Approval for the funding allocation of the said Project;

WHEREAS, the City genuinely welcomes and deeply appreciates the contribution of the private sector in assisting the former in its endeavors toward the attainment of general welfare for the people especially in the domain of health;

WHEREAS, to concretize the partnership, a Memorandum of Agreement was prepared, delineating the terms of the agreement as well as the complementary duties and responsibilities of the parties;

WHEREAS, as reviewed by the City Legal Department of Mandaluyong, the Agreement appear to be reasonable as to their terms and responsive to the sought intent by the parties;

WHEREAS, considering the feasibility of the Agreement and to implement the provisions of the same, the Local Government Code requires that a Sanggunian Resolution be issued first before the Local Chief Executive may be authorized to sign the subject Agreement in representation of the Local Government Unit.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Memorandum Agreement and other relevant documents to be executed by the City Government of Mandaluyong, Melco Resorts (Philippines) Foundation Corporation, and Melco Resorts Leisure (PHP) Corporation for the provision of financial assistance amounting to Twenty Million Pesos (Php20,000,000.00) for the purchase of several vaccines to be distributed and administered within the City of Mandaluyong.

RESOLVED FURTHER, that copy of this Resolution be furnished to the Office of the City Mayor, Melco Resorts (Philippines) Foundation Corporation, and Melco Resorts Leisure (PHP) Corporation, and other pertinent departments and offices for their information and appropriate action.

ADOPTED on this 13<sup>th</sup> day of November 2023, in the City of Mandaluyong.


