RESOLUTION NO. 3385, S-2024

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO DONATE THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP500,000.00) TO THE MUNICIPALITY OF BURDEOS, QUEZON FOR ITS "BURDEOS BAYANIHAN PABAHAY PROJECT" AND OTHER RELATED REHABILITATIVE HOUSING MEASURES, PROJECTS, AND PROGRAMS

WHEREAS, Section 33 of the Local Government Code of 1991 provides that "(L)ocal government units may, through appropriate Ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them. In support of such undertakings, the local government units involved may, upon approval by the Sanggunian concerned after a public hearing conducted for the purpose, contribute funds, real estate, equipment, and other kinds of property and appoint or assign personnel under such terms and conditions as may be agreed upon by the participating local units through Memoranda of Agreement";

WHEREAS, pursuant to the abovementioned provision, sisterhood or twinning agreements between cities and municipalities in the Philippines are forged geared towards the betterment of the participating cities and municipalities;

WHEREAS, the City of Government of Mandaluyong, by virtue of Resolution No. 1962, S-2014 and its corresponding Sisterhood and Twinning Negotiation and Agreement, has been a steadfast and reliable Sister City of the Municipality of Burdeos, Quezon in the promotion of business, trade, commerce, tourism, and industry in the said locality;

WHEREAS, as a Sister City of the Municipality of Burdeos, Quezon Province, the City of Mandaluyong remains committed to aid and assist the Municipality of Burdeos, Quezon in sustaining the consistent growth of the Municipality it achieved through the years;

WHEREAS, the Municipality of Burdeos has been in a state of turmoil after having been hit by Typhoon Karding, leaving a considerable number of constituents and the communities within the locality of Burdeos devastated;

WHEREAS, Typhoon Karding left the residents of the Municipality homeless and helpless, leading up to the initiative "Burdeos Bayanihan Pabahay Project" which aims to address the predicament it currently faces;

WHEREAS, in furtherance of the said Project, the Municipality of Burdeos, through Sangguniang Bayan Resolution No. 135 – 2022, humbly knocked on the doors of the City of Mandaluyong and requested financial assistance amounting to Five Hundred Thousand Pesos (Php500,000.00) which will be utilized for the Project, and more importantly, alleviate and address the uncertainty faced by the residents of Burdeos;

WHEREAS, the City of Mandaluyong, in view of its strong ties with the Municipality of Burdeos and its deepest intent to support the Municipality in its programs and projects, willingly intends to donate the requested amount.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to donate the amount of Five Hundred Thousand Pesos (Php500,000.00) to the Municipality of Burdeos, Quezon in support of its Burdeos Bayanihan Pabahay Project, subject to existing auditing laws, rules, and regulations.

RESOLVED FURTHER, that the donated amount shall be exclusively utilized by the Municipality of Burdeos for the Burdeos Bayanihan Pabahay Project and other related rehabilitative housing measures for the benefit of the Municipality's constituents.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, City Budget Department, City Accounting Department, and City Treasurer's Department and the Sangguniang Pambayan ng Burdeos, Quezon Province for their immediate information.

RESOLVED FINALLY, that this Resolution shall take effect immediately upon its approval.


