RESOLUTION RATIFYING, CONFIRMING, AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MANDALUYONG FOR THE YEAR 2024 TO INCLUDE THE PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) OF THE HUMAN RESOURCE AND MANAGEMENT DEPARTMENT (HRMD) UNDER PERSONAL SERVICES TO BE COVERED BY A SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2024

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and adopted the Annual Investment Program (AIP) for the year 2024;

WHEREAS, due to the exigencies of public service and to maximize the utilization of funds before the year ends, there are various programs, projects and activities (PPAs), specifically the intended mass promotion to casual status of the estimated three hundred (300) Job Orders and one hundred (100) Service Contractuals that need to be funded and implemented by the Human Resource and Management Department (HRMD);

WHEREAS, the sources of funds for these various PPAs have been identified and will be appropriated through a Supplemental Budget for CY 2024;

WHEREAS, there is, therefore, a need to submit a supplemental AIP to reflect the changes on the original approved AIP to include those PPAs of the HRMD.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod RESOLVED, as it hereby RESOLVES, to approve, ratify, and confirm the Supplemental Annual Investment Program (AIP) for Calendar Year 2024 of the City Government of Mandaluyong to include those PPAs of the HRMD under Personal Services to be covered by the Supplemental Budget for Calendar Year 2024.

RESOLVED FINALLY, to furnish copy of this Resolution to the Office of the City Mayor, City Human Resource and Management Department, City Budget Department, City Accounting Department and City Treasury Department for their information, guidance and reference.


