**RESOLUTION 3516, S-2024**

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE DEED OF DONATION WITH THE MUNICIPALITY OF BINMALEY, PROVINCE OF PANGASINAN FOR VARIOUS DRUGS AND MEDICINE TO BE UTILIZED EXCLUSIVELY IN FAVOR OF ONE THOUSAND (1000) SENIOR CITIZEN RESIDENTS OF MUNICIPALITY OF BINMALEY, PROVINCE OF PANGASINAN

WHEREAS, Section 16 of the Local Government Code (LGC) provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 22 of the LGC likewise provides that every local government unit, as a corporation, shall have the power to enter into contracts, convey real properties, as well as exercise such other powers as are granted to corporations;

WHEREAS, the City of Mandaluyong, as a once-developing City, gives primary importance in partnering with the National Government, other local government units, and the private sector in furtherance of greater public interest and expanded provision of basic services, including reinforced medical assistance in all forms;

WHEREAS, as one of the Sister localities of the City of Mandaluyong, the Municipality of Binmaley, Province of Pangasinan ("Municipality of Binmaley") places primacy on the health and welfare of its senior citizen residents, including assistance extended by the public and private sector, as this sector is deemed to be valuable part and metric of its growth as a locality;

WHEREAS, with the bonded partnership of both localities signified by the City's Resolution No. 3468, S-2024 and further confirmed by the execution of the corresponding Sisterhood Agreement, it is innate in the said partnership that common goals for the benefit of their constituents be achieved through concerted efforts;

WHEREAS, considering this priority aspect in the said Municipality's governance, the City of Mandaluyong intends to extend its helping hand to the Municipality of Binmaley for the provision of various drugs and medicine to be utilized exclusively in favor of one thousand (1000) of its senior citizen residents and for which a Deed of Donation was drafted, particularly:

WHEREAS, as reviewed by the City Legal Department, the Deed appears to be reasonable as to their terms and responsive to the sought action by the City;


WHEREAS, the Local Government Code requires that a Sanggunian Resolution be issued first before the Local Chief Executive may be authorized to sign contracts in representation of the local government unit.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Deed of Donation with the MUNICIPALITY OF BINMALEY, PROVINCE OF PANGASINAN for the donation of various drugs and medicine to be utilized exclusively in favor of one thousand (1000) senior citizen residents of the said Municipality;


