RESOLUTION NO. 3518, S-2024

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE PROJECT CONTRACT WITH DDT KONSTRACKT, INC. FOR THE CONSTRUCTION OF THE UNDERGROUND ELECTRICAL AND AUXILLARY DISTRIBUTION SYSTEM OF MANDALUYONG PHASE 1, PACKAGE A, CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the construction of the underground electrical and auxillary distribution system of Mandaluyong Phase 1, Package A, City of Mandaluyong;

WHEREAS, on September 10, 2024, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein the lone bidder participated by submitting its abstract of the proposal to the Bids and Awards Committee;

WHEREAS, in the aforesaid public bidding, the firm doing business under the name of DDT Konstrack, Inc., with business address at Unit 1206, 12th Floor, The Olive Place, 407 Shaw Blvd., Barangay Addition Hills, Mandaluyong City has been established to have the Single Calculated and Responsive Bid (SCRB) in the amount of ONE HUNDRED SEVEN MILLION EIGHT HUNDRED EIGHTY EIGHT THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS (₱107,888,888.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;


WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.

NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of DDT Konstrack, Inc. is the Single Calculated and Responsive Bid and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor Benjamin S. Abalos, to sign the Project Contract with DDT Konstrack, Inc. for the construction of the underground electrical and auxillary distribution system of Mandaluyong Phase 1, Package A, City of Mandaluyong.
