RESOLUTION NO. 3522, S-2024

A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF GASAN, PROVINCE OF MARINDUQUE THROUGH ITS MUNICIPAL MAYOR, HON. ROLANDO O. TOLENTINO, AND FURTHER AUTHORIZING THE CITY MAYOR, HON. BENJAMIN S. ABALOS, TO SIGN THE SISTERHOOD PACT

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that “Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them”;

WHEREAS, it is the desire of the Municipality of Gasan, Province of Marinduque to improve and accelerate its present phase of living by expanding connections and forging linkages with other municipalities and cities to bring about progress and advancement in the fields of business investments, tourism, health and education that would benefit its constituents;

WHEREAS, the Municipality of Gasan, Province of Marinduque, by virtue of RESOLUTION NO. 2023-08-168, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila to foster camaraderie, oneness, unity and cooperation with government units through constant communication and exchanges in visits and cultural traditions;

WHEREAS, a bonding tie of sisterhood between the Municipality of Gasan, Province of Marinduque and Mandaluyong City, Metro Manila will foster mutual friendship and goodwill, nurture closer relationship among their people and closer social and cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the city's philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Gasan, Province of Marinduque;


NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION DULY ASSEMBLED, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Gasan, Province of Marinduque through its Municipal Mayor, Hon. Rolando O. Tolentino, and further authorizing the City Mayor, Hon. Benjamin S. Abalos, to sign the sisterhood pact.

Let copy of this Resolution be furnished to the Honorable City Mayor Benjamin S. Abalos, the Municipality of Gasan, Province of Marinduque through its Municipal Mayor, Hon. Rolando O. Tolentino, and the Department of the Interior and Local Government for their information, guidance and reference.

This Resolution shall take effect immediately upon its approval.


