A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE SCHOLARSHIP SERVICE CONTRACT AND OTHER RELATED AGREEMENTS WITH THE DEPARTMENT OF HEALTH (DOH) FOR THE SCHOLARSHIP GRANT TO DR. DAISY S. COSTALES

WHEREAS, the Department of Health gives importance to the academic development of health workers as they continue in their service through the Department of Health Local In-Service Scholarship (DOH LSP);

WHEREAS, Dr. Daisy S. Costales has qualified to be one of the beneficiaries of the DOH LSP with the Ateneo School of Government (ASoG) – Master in Public Management – Health Governance Track;

WHEREAS, the City Government of Mandaluyong recognizes that this is a great opportunity to the professional development of Dr. Daisy S. Costales and by extension to the City itself;

WHEREAS, no money shall be taken from the City's coffers to defray any expenses on the project, thus, entering the agreement will be advantageous to the City of Mandaluyong;

WHEREAS, Dr. Daisy S. Costales shall be on official business during the period that she will undertake her studies as provided by the agreement;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that will govern the parties' complementary duties and responsibilities, and the same has been found reasonably and properly crafted and in accordance with law;



ADOPTED on this 18<sup>th</sup> day of November 2024, in the City of Mandaluyong.


