**RESOLUTION AUTHORIZING THE HONORABLE CITY
MAYOR BENJAMIN S. ABALOS TO SIGN THE PROJECT
CONTRACT WITH WHITEPORT, INC. FOR THE
CONSTRUCTION OF A MULTI-PURPOSE BUILDING
(PHASE 2) LOCATED AT THE CITY HALL COMPLEX,
MAYSILO CIRCLE, BARANGAY PLAINVIEW, CITY OF
MANDALUYONG**

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the construction of a Multi-Purpose Building (Phase 2) located at the City Hall Complex, Maysilo Circle, Barangay Plainview, City of Mandaluyong;

WHEREAS, on November 19, 2024 a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein the lone bidder participated by submitting its abstract of the proposal to the Bids and Awards Committee;

WHEREAS, in the aforesaid public bidding, the firm doing business under the name of Whiteport, Inc., with business address at Unit 1201, 12th Floor, The Olive Place, 407 Shaw Blvd., Brgy. Addition Hills, Mandaluyong City has been established to have the Single Calculated and Responsive Bid (SCRB) in the amount of NINETY NINE MILLION TWO HUNDRED EIGHTY EIGHT THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS (₱99,288,888.00) only;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;

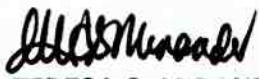

Abalos, to sign the Project Contract with Whiteport, Inc. for the construction of Multi-Purpose Building (Phase 2) located at City Hall Complex, Maysilo Circle, Barangay Plainview, City of Mandaluyong.

ADOPTED on this 2nd day of December 2024, in the City of Mandaluyong.

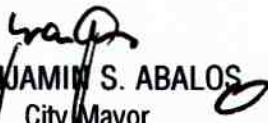
