



RESOLUTION NO. 3537, S-2024

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO DONATE THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) TO EACH SISTER-MUNICIPALITY OF THE PROVINCE OF CATANDUANES CONSISTING OF THE MUNICIPALITIES OF PANGANIBAN, BATO, SAN ANDRES AND BAGAMANOC, TO BE UTILIZED TO SUPPORT THE DAMAGE, RECOVERY AND RELIEF EFFORTS FOR THE VICTIMS OF TYPHOON PEPITO

WHEREAS, recently, one of the strongest typhoons in history “Typhoon Pepito” struck the country, and destroyed properties and lives of many;

WHEREAS, Typhoon Pepito has made a landfall as a super typhoon in Panganiban, Catanduanes on Saturday evening of November 16, 2024;

WHEREAS, Typhoon Pepito has caused significant damage, displaced numerous families and severe loss of life and property in the province of Catanduanes specifically the Municipalities of Panganiban, Bato, San Andres and Bagamanoc, leaving the communities in urgent need of relief and recovery assistance;

WHEREAS, the Municipalities of Panganiban, Bato, San Andres and Bagamanoc, Province of Catanduanes, sister-municipalities of the City of Mandaluyong, have been determined to have insufficient resources to sustain the current aid, relief, rehabilitation, and reconstruction efforts for the communities;

WHEREAS, through the initiative and able leadership of the Honorable Benjamin S. Abalos with the support of the City Council, in his capacity as the City Mayor and Chairperson of the Mandaluyong City Disaster Risk Reduction and Management Council (Mandaluyong CDRRMC), the City Government of Mandaluyong desires to give aid and assistance in the areas most devastated by the typhoon;

WHEREAS, Section 1 of Rule 18 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as “An Act Strengthening the Philippine Disaster Risk Reduction and Management System (PDRRMS) providing for the National Disaster Risk Reduction and Management Plan (NDRRMP), Appropriating Funds Therefor and for Other Purposes”, allows a portion of the Local Disaster Risk Reduction and Management Fund (LDRRMF) to be used by the City Government of Mandaluyong to render assistance to the typhoon-hit local government units (LGUs) like the sister-Municipalities of Panganiban, Bato, San Andres and Bagamanoc, Catanduanes;

WHEREAS, the City Government of Mandaluyong recognized the need to provide immediate assistance to the affected communities to alleviate their hapless plight and to support recovery efforts in the areas affected by the Pepito onslaught;

WHEREAS, in furtherance of these humanitarian efforts, this Sangguniang Panlungsod deems that there is a need to donate the amount of ONE MILLION PESOS (P1,000,000.00) to each sister-Municipality chargeable against the Quick Response Fund of the Local Disaster Risk Reduction and Management Fund (LDRRMF) of the City subject to applicable accounting and auditing laws, rules and regulations.


NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to donate the amount of ONE MILLION PESOS (P1,000,000.00) to each sister-Municipality of the Province of Catanduanes, consisting of the Municipalities of Panganiban, Bato, San Andres and Bagamanoc, to be utilized to support the damage, recovery and relief efforts for the victims of Typhoon Pepito, subject to existing laws and regulations therefor.

ADOPTED on this 2<sup>nd</sup> day of December 2024, in the City of Mandaluyong.


