WHEREAS, ATTY. CHERRY LYNN P. SANTOS graduated with a degree in AB Liberal Arts at the De la Salle University in 1993 and at the Arellano University School of Law with the degree of Bachelor of Laws/Juris Doctor in 2014; She is a holder of RA 1080 Career Service Eligibility;

WHEREAS, ATTY. CHERRY LYNN P. SANTOS was formerly a Member of the Sangguniang Panlungsod ng Mandaluyong from 1999 to 2010 and from 2013 to 2022;

WHEREAS, her other government experiences include: Administrative Officer at the City Administrator's Department from July 2010 to September 2012; Supervising Manpower Development Officer at the Mandaluyong Manpower and Technical Vocational Training Services from June 2022 to November 30, 2024, and acted in concurrent capacity as Officer-in-Charge at the Barangay Affairs and Community Services Department;

WHEREAS, her appointment as City Government Department Head II in the City Barangay Affairs and Community Services Department is considered as a promotion premised on her qualifications, familiarity with the job, accomplishments in the past, trainings and work experience, known probity and competence that has gained the trust and respect of the appointing authority stemmed from her exceptional performance as Supervising Manpower Development Officer;

WHEREAS, the services of ATTY. CHERRY LYNN P. SANTOS were found to be very satisfactory making her deserving to be appointed to the said position and accordingly, the Sangguniang Panlungsod of the City of Mandaluyong deems it necessary to confirm and ratify her appointment as City Government Department Head II;


