RESOLUTION NO. 3544, S-2024

A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF BATAN, PROVINCE OF AKLAN THROUGH ITS MUNICIPAL MAYOR, HONORABLE MICHAEL R. RAMOS, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE BENJAMIN S. ABALOS, TO SIGN THE SISTERHOOD PACT

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that “Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them”;

WHEREAS, it is the desire of the Municipality of Batan, Province of Aklan to expand its horizon through linkages with other local government units, thus, opening the opportunity for community development and nation building;

WHEREAS, the Municipality of Batan, Province of Aklan, by virtue of RESOLUTION NO. 2023-19, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila to strengthen and uplift the socio-economic and cultural relations between the two local government units;

WHEREAS, a bonding tie of sisterhood between the Municipality of Batan, Province of Aklan and Mandaluyong City, Metro Manila will foster mutual friendship and goodwill, nurture closer relationship among their people and closer social and cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the City’s philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Batan, Province of Aklan.


NOW, THEREFORE, be it RESOLVED, as it is hereby RESOLVED by the Sangguniang Panlungsod of Mandaluyong, by virtue of the powers vested in it by law, in session duly assembled, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Batan, Province of Aklan through its Municipal Mayor, Honorable Michael R. Ramos, and further authorizing the City Mayor, Honorable Benjamin S. Abalos, to sign the sisterhood pact.


