RESOLUTION NO. 3548A, S-2024

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE PROJECT CONTRACT WITH CLEANWAY ENVIRONMENTAL MANAGEMENT SOLUTIONS, INC. FOR THE COLLECTION, PROCESSING, AND DISPOSAL SERVICES OF HOSPITAL WASTE FOR THE MANDALUYONG CITY MEDICAL CENTER (MCMC), CITY OF MANDALUYONG

WHEREAS, the Bids and Awards Committee of the City of Mandaluyong caused the issuance of an Invitation to Bid for the Collection, Processing, and Disposal Services of Hospital Waste for the Mandaluyong City Medical Center (MCMC), City of Mandaluyong;

WHEREAS, on November 26, 2024, a public bidding was held at the Conference Room, Office of the Mayor, 4/F Executive Building, City Hall Complex, Mandaluyong City, wherein two (2) bidders participated by submitting their abstract of the proposals to the Bids and Awards Committee;

WHEREAS, of the two (2) bidders that participated in the aforesaid public bidding, the firm doing business under the name of Cleanway Environmental Management Solutions, Inc. with business address at Blk. 4, Lot 1-8, Meridian Industrial Complex II, Brgy. Maguyam, Silang, Cavite has been established to have the Lowest Calculated Responsive Bid in the amount of EIGHT MILLION SIX HUNDRED FORTY THOUSAND PESOS (P8,640,000.00) for one (1) year;

WHEREAS, the said project was duly conducted in accordance with the Procurement laws and rules;

WHEREAS, the Sangguniang Panlungsod has acted based on the documents submitted by the Bids and Awards Committee (BAC) and adhered that the undertaking of the Officers involved therein performed an orderly conduct of the bidding;

WHEREAS, the completion of the proposed project will redound to the best interest of the affected community, in particular, and the entire City of Mandaluyong, in general.


NOW, THEREFORE, and upon motion duly seconded, and finding that the offer of Cleanway Environmental Management Solutions, Inc. is the lowest and most advantageous to the City of Mandaluyong, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to sign the Project Contract with Cleanway Environmental Management Solutions, Inc. for the Collection, Processing, and Disposal Services of Hospital Waste for the Mandaluyong City Medical Center (MCMC), City of Mandaluyong.
