RESOLUTION NO. 3565, S-2025

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO DONATE THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) IN FAVOR OF THE PROVINCE OF NORTHERN SAMAR TO BE UTILIZED TO SUPPORT THE DAMAGE, RECOVERY AND RELIEF EFFORTS FOR THE VICTIMS OF TYPHOON PEPITO

WHEREAS, recently, a Low-Pressure Area (LPA) turned into typhoon Pepito has caused damage to many lives and properties in the Province of Northern Samar triggering flash floods and landslides and continued to affect Northern Samar due to the shearline;

WHEREAS, typhoon Pepito has caused significant damage, displaced numerous families and severe loss of life and property in the Province of Northern Samar leaving the community in urgent need of relief and recovery assistance;

WHEREAS, through the initiative and able leadership of the Hon. Benjamin S. Abalos, with the support of the City Council, in his capacity as the City Mayor and Chairperson of the Mandaluyong City Disaster Risk Reduction and Management Council (Mandaluyong CDRRMC), the City Government of Mandaluyong desires to give aid and assistance in the areas most devastated by the typhoon;

WHEREAS, this initiative aims to alleviate the financial burdens faced by individuals and families in Northern Samar as they recover from the impact of the storm;

WHEREAS, Section 1 of Rule 18 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as "An Act Strengthening the Philippine Disaster Risk Reduction and Management System (PDRRMS) providing for the National Disaster Risk Reduction and Management Plan (NDRRMP), Appropriating Funds Therefor and For Other Purposes", allows a portion of the Local Disaster Risk Reduction and Management Fund (LDRRMF) to be used by the City Government of Mandaluyong to render assistance to the typhoon-hit local government units (LGUs) like the Province of Northern Samar;

WHEREAS, in furtherance of this humanitarian effort, this Sangguniang Panlungsod deems that there is a need to donate the amount of ONE MILLION PESOS (P1,000,000.00) chargeable against the Quick Response Fund of the Local Disaster Risk Reduction and Management Fund (LDRRMF) of the City subject to applicable accounting and auditing laws, rules and regulations.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to donate the amount of ONE MILLION PESOS (P1,000,00,000.00) to the Province of Northern Samar, to be utilized to support the damage, recovery and relief efforts for the victims of Typhoon Pepito.
