RESOLUTION NO. 3580, S-2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR BENJAMIN S. ABALOS TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT AND GOLDEN ARCHES DEVELOPMENT CORPORATION CONCERNING THE EMPLOYMENT IN MCDONALD'S BRANCHES OF ELIGIBLE SENIOR CITIZENS OF THE CITY OF MANDALUYONG

WHEREAS, Article XIII, Section 9, of the 1987 Constitution provides that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, Republic Act No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010", has the objective of giving full support to the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens are an integral part of Philippine society, among others, and recognizes the important role of the private sector in the improvement of the welfare of senior citizens;

WHEREAS, the Department of Labor and Employment ("DOLE"), through its Regional and Field Offices, in pursuance of its mandate to formulate and implement policies and programs serves as the policy-advisory arm of the Executive Branch of the Government of the Republic of the Philippines in the fields of labor and employment, implements programs pursuant to the 1987 Constitution and Republic Act No. 9994;

WHEREAS, Public Employment Service Office (PESO) is an employment facilitation service machinery of the Republic of the Philippines, mandated by Republic Act No. 8759 to be established, operated and maintained by Local Government Units while linked with the DOLE, is tasked to ensure the prompt, timely, and efficient delivery of employment services and provision of information on DOLE programs;

WHEREAS, Golden Arches Development Corporation (GADC) is the holder of the McDonald's license in the Philippines and operates various McDonald's restaurants nationwide. Pursuant to its mission to contribute to economic development and to give back to the communities it serves, GADC desires to initiate programs for and open its facilities to accommodate qualified senior citizens and elderly individuals for employment in its McDonald's stores;

WHEREAS, GADC aims to employ qualified and eligible elderly individuals specifically senior citizens under its program through the PESO-Mandaluyong, hence, a Memorandum of Agreement must be executed by the Parties to outline their respective obligations concerning the sprogram;

WHEREAS, Section 22 of the Local Government Code gives Mandaluyong City, as represented by its Local Chief Executive, the power to enter into contracts, after being authorized by the Sanggunian.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session duly assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor BENJAMIN S. ABALOS to enter into and sign the Memorandum of Agreement with the Department of Labor and Employment and Golden Arches Development Corporation concerning the program for the employment of eligible senior citizens of Mandaluyong City in various McDonald's branches.


RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, PESO-Mandaluyong, City Administrator's Department and other pertinent Departments and Offices.

ADOPTED on this 10th day of February 2025, in the City of Mandaluyong.
