**RESOLUTION NO. 3581, S-2025**

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) REGARDING THE RENEWAL OF THEIR PARTNERSHIP FOR THE USE AND IMPLEMENTATION OF THE INTEGRATED CLINIC INFORMATION SYSTEM (ICLINICSYS)

WHEREAS, Local Government Units, as mandated by Republic Act No. 7160, also known as the 1991 Local Government Code, are responsible to deliver basic health services and facilities to its constituents;

WHEREAS, the Department of Health (DOH), by virtue of its mandate, holds the overall technical authority in health with three major roles: leadership and regulation in health, enabling and capacity building, and administration of special health services;

WHEREAS, the Integrated Clinic Information System (iClinicSys) Program was introduced by the DOH as a reference model for electronic medical records and health information systems for primary care facilities designed to meet the requirements of the Philippine Health Insurance Corporation for benefit packages through capitation. Likewise, it fulfills the DOH's reporting necessities, including compliance with national health data standards;

WHEREAS, the iClinicSys Program was initially implemented in the City of Mandaluyong in 2017;


WHEREAS, the City of Mandaluyong and the DOH desire to continually implement the use of the iClinicSys by the LGU, thus, the necessity for the execution of another Memorandum of Agreement to renew their partnership.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor BENJAMIN S. ABALOS to enter into and sign the Memorandum of Agreement with the Department of Health-Metro Manila Center for Health Development regarding the renewal of the implementation of the iClinicSys Program within the City of Mandaluyong for three (3) years.

RESOLVED, that a copy of this Resolution be furnished to the Office of the City Mayor and the City Health Department.


