RESOLUTION NO. 3589, S-2025

A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF MABITAC, PROVINCE OF LAGUNA THROUGH ITS MUNICIPAL MAYOR, HON. ALBERTO S. REYES, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE BENJAMIN S. ABALOS, TO SIGN THE SISTERHOOD PACT

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that "Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them";

WHEREAS, it is the desire of the Municipality of Mabitac, Province of Laguna to expand its horizon through linkages with other local government units, thus, opening opportunities for community development and nation building;

WHEREAS, the Municipality of Mabitac, Province of Laguna, by virtue of RESOLUTION NO. 36, Series of 2025, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila to strengthen friendship ties and to create framework for effective communication that will facilitate the exchange of information and technology, urban planning policies, and the development of socio-cultural activities, including income generation strategies and fiscal management;

WHEREAS, a bonding tie of sisterhood between the Municipality of Mabitac, Province of Laguna and Mandaluyong City, Metro Manila will promote mutual friendship and goodwill, foster closer relationship among its people and closer social and cultural exchanges and economic ties between the two local governments;

WHEREAS, in consideration of the City's philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Mabitac, Province of Laguna.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION DULY ASSEMBLED, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Mabitac, Province of Laguna through its Municipal Mayor, Hon. Alberto S. Reyes, and further authorizing the City Mayor, Hon. Benjamin S. Abalos, to sign the sisterhood pact.

Let copy of this Resolution be furnished to the Honorable City Mayor Benjamin S. Abalos, the Municipality of Mabitac, Province of Laguna through its Municipal Mayor, Hon. Alberto S. Reyes, and the Department of the Interior and Local Government for their information, guidance and reference.


This Resolution shall take effect immediately upon its approval.
