**RESOLUTION NO. 3593, S-2025**

**A RESOLUTION ENDORSING THE ESTABLISHMENT OF SISTERHOOD AGREEMENT BETWEEN MANDALUYONG CITY, METRO MANILA AND THE MUNICIPALITY OF BOMBON, PROVINCE OF CAMARINES SUR THROUGH ITS MUNICIPAL MAYOR, HONORABLE EDDIE FELIX S. ALTEZA, AND FURTHER AUTHORIZING THE CITY MAYOR, HONORABLE BENJAMIN S. ABALOS, TO SIGN THE SISTERHOOD PACT**

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that "Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them";

WHEREAS, it is the desire of the Municipality of Bombon, Province of Camarines Sur to expand its horizon through linkages with other local government units, thus, opening opportunities for community development and nation building;

WHEREAS, the Municipality of Bombon, Province of Camarines Sur, by virtue of RESOLUTION NO. 2025-60, aims to establish a sisterhood relationship with the City of Mandaluyong, Metro Manila to promote cultural exchange, economic collaboration, and the sharing of best practices in governance, public service, and sustainable development;

WHEREAS, a bonding tie of sisterhood between the Municipality of Bombon, Province of Camarines Sur and Mandaluyong City, Metro Manila will provide opportunities for collaboration in various fields, including but not limited to trade and investment, tourism promotion, education, health services, and disaster risk reduction and management;

WHEREAS, in consideration of the City's philosophy of cooperation, the Sangguniang Panlungsod of Mandaluyong observes no reason not to consider this diplomatic measure in the spirit of goodwill, peace and development, and as such, favorably endorses the establishment of a sisterhood pact between Mandaluyong City, Metro Manila and the Municipality of Bombon, Province of Camarines Sur.


NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MANDALUYONG, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION DULY ASSEMBLED, to endorse the establishment of sisterhood agreement between the City of Mandaluyong, Metro Manila and the Municipality of Bombon, Province of Camarines Sur through its Municipal Mayor, Honorable Eddie Felix S. Alteza, and further authorizing the City Mayor, Honorable Benjamin S. Abalos, to sign the sisterhood pact.

Let copy of this Resolution be furnished to the Honorable City Mayor Benjamin S. Abalos, the Municipality of Bombon, Province of Camarines Sur through its Municipal Mayor, Honorable Eddie Felix S. Alteza, and the Department of the Interior and Local Government for their information, guidance and reference.

This Resolution shall take effect immediately upon its approval.
