RESOLUTION NO. 3611, S-2025

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE TERMS OF PARTNERSHIP BETWEEN THE CITY GOVERNMENT OF MANDALUYONG AND THE DEPARTMENT OF HEALTH – METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) REGARDING THE IMPLEMENTATION OF THE ANNUAL OPERATION PLAN FOR HEALTH OF THE CITY GOVERNMENT FOR THE YEAR 2025

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution emphasizes the State's policy of protecting and promoting the right to health of the people and instilling health consciousness among them;

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods and health and social services available to all people at an affordable cost;

WHEREAS, Republic Act No. 11223 or the Universal Health Care Act of 2019 seeks to "progressively realize universal health care in the country through a systemic approach and clear delineation of roles of key agencies and stakeholders towards better performance in the health system" and "ensure that all Filipinos are guaranteed equitable access to quality and affordable health care goods and services, and protected against financial risk;"

WHEREAS, Section 22 of R.A. No. 11223 mandates the National Government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health, and health commodities, to improve the functionality of citywide health systems, provided that such grants shall be in accordance with the approved citywide health investment plans;

WHEREAS, the City Government of Mandaluyong has the responsibility to provide for the general welfare of its residents, particularly providing quality medical and health services;

WHEREAS, the City Government of Mandaluyong endeavors to fully implement the corresponding local health system reforms targeted under the Universal Health Care Act of 2019 and has proven its capacity to utilize investments and sustain the reform process;

WHEREAS, the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD) has manifested its willingness to work together with the City Government of Mandaluyong to carry out the health sector reforms under the Universal Health Care Act;

WHEREAS, Administrative Order No. 2020-0018 or the Guidelines on Contracting Province-Wide and City-Wide Health Systems describes the Terms of Partnership as the legal instrument that formalizes the agreement between the DOH and the LGU to implement the Annual Operation Plan;

WHEREAS, the City Legal Department reviewed the draft of the Terms of Partnership that will govern the parties' corresponding roles and responsibilities, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable City Mayor BENJAMIN S. ABALOS to enter into and sign the Terms of Partnership between the City Government of Mandaluyong and the Department of Health – Metro Manila Center for Health Development (DOH-MMCHD) regarding the Implementation of the Annual Operation Plan of the City Government for Health for the year 2025.


