**RESOLUTION NO. 3614, S-2025**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO ENTER INTO AND SIGN THE ADDENDUM TO EXTEND MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY REGARDING THE CONTINUOUS IMPLEMENTATION OF THE POPCEN-CBMS WITHIN MANDALUYONG CITY**

WHEREAS, Republic Act No. 10625, otherwise known as the Philippine Statistical Act of 2013, mandates the Philippine Statistics Authority (PSA) to collect, compile, analyze, abstract, and publish statistical information relating to the country's economic, social, demographic, political affairs and general activities and condition of the people;

WHEREAS, Republic Act No. 11315 or the Community Based Monitoring System Act, institutionalizes a Community-Based Monitoring System (CBMS) in every city and municipality as an economic and social tool towards the formulation and implementation of poverty alleviation and development programs which are specific, targeted and responsive to the basic needs of each sector of the community, with appropriate security measures for data protection;

WHEREAS, Section 5 of the immediately cited legislation provides that, every three (3) years, regular and synchronized data collection shall be conducted by every city and municipality, as the primary data collecting authority within its locality, and for such purpose, the Local Government Unit (LGU) shall be given assistance from the appropriate national government agencies (NGAS);

WHEREAS, to ensure the updating of mid-decade inventory of the population of the entire Philippines while ensuring the updating of social registries of NGAS and LGUs for evidence-based project development and program implementation, a nationwide simultaneous conduct of Census of Population (POPCEN) and CBMS in 2024 (2024 POPCEN-CBMS) will be led by the PSA;

WHEREAS, to formalize the City of Mandaluyong's participation in the 2024 POPCEN-CMBS, and to outline the duties and responsibilities of the City of Mandaluyong and the PSA in the conduct of the activity, the PSA proposed for the execution of a Memorandum of Agreement (MOA);

WHEREAS, the parties entered into the MOA on 03 July 2024, with the City of Mandaluyong leading the implementation of the CBMS on behalf of the PSA in the City of Mandaluyong;

WHEREAS, with the on-going implementation of the CBMS, the PSA proposed for the extension of the term of the original PSA, through an Addendum to Extend Memorandum of Agreement ("Addendum"), in order for the parties to conduct additional activities in furtherance of its intent to successfully complete the project;

WHEREAS, with the same having been reviewed by the City Legal Department, the said Addendum appears to be in accordance with the law and is reasonably and properly crafted, with the same reflecting an extended term for the implementation of the CBMS and the continuous accomplishment of the parties' respective duties and responsibilities under the original MOA;

WHEREAS, to act on behalf of the City Government of Mandaluyong, there exists a need to authorize the City Mayor, Honorable Benjamin S. Abalos, to enter into and sign the Addendum between the PSA and the City Government of Mandaluyong, through an appropriate Sangguniang Panlungsod resolution.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor BENJAMIN S. ABALOS to enter into and sign the Addendum to Extend Memorandum of Agreement with the Philippine Statistics Authority for the continuous implementation of the POPCEN-CBMS within the City's territorial jurisdiction.

RESOLVED FURTHER, that copy of this Resolution be furnished to the Office of the City Mayor, City Administrator, City Budget Department, and the City Planning and Development Department for their information and guidance.

RESOLVED FINALLY, this Resolution shall take effect immediately upon its approval.


