RESOLUTION NO. 3620, S-2025

A RESOLUTION ADOPTING REPUBLIC ACT NO. 11261 OR THE "FIRST TIME JOBSEEKERS ASSISTANCE ACT" AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR)

WHEREAS, it is the policy of the State to promote full employment and equality of gainful work and opportunities for its citizens, including the expansion of accessibility to government services and provide incentives to improve a first time jobseeker's access to employment;

WHEREAS, the State, likewise, adopts the International Labour Organization's (ILO) Principle of Employment Policy that fully recognizes the implementation of economic and social policies in promoting full and productive employment;

WHEREAS, towards this end, Republic Act No. 11261 or the "First Time Jobseekers Assistance Act" was enacted, which seeks, among others, to waive government fees and charges in the issuance of documents required in the application for employment of first time jobseekers and sought in connection with the application for and the granting of licenses, proofs of identification, clearances, certificates or other documents usually required in the course of employment locally or abroad;

WHEREAS, the scope of the enactment covers all government agencies and instrumentalities, including government-owned and controlled corporations (GOCCs), local government units (LGUs), and government hospitals, thus including the City of Mandaluyong;

WHEREAS, a corresponding Implementing Rules and Regulations (IRR) was thereafter issued particularly delineating the covered beneficiaries, rules of eligibility, and other relevant requirements, including the governmental transactions for which the waiver shall apply;

WHEREAS, as an over-arching imposition upon all local government units, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 provides for the duty of local government units to ensure and support, among other things, enhance economic prosperity and social justice and promote full employment among their residents;

WHEREAS, the City of Mandaluyong, in line with the objectives of the Republic Act No. 11261 or the "First Time Jobseekers Assistance Act", intends to adopt the vision espoused by the said legislation and promote, to the fullest extent, its implementation.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to adopt the provisions of Republic Act No. 11261 or the "First Time Jobseekers Assistance Act" and its Implementing Rules and Regulations.

RESOLVED FURTHER, that the Public Employment Services Department (PESD) is, likewise, directed to implement the provisions of the said Act for monitoring purpose.

RESOLVED FURTHER, that an Executive Order shall subsequently be issued by the Local Chief Executive to localize the provisions of the First Time Jobseekers Assistance Act and its Implementing Rules and Regulations, including, among others, provisions relating to the particular fees and charges covered within the City Government of Mandaluyong, qualifications for eligible beneficiaries, and the duties and responsibilities of relevant offices and the City's component barangays.

RESOLVED FURTHER, that the necessary funding, if necessary, shall be allotted or appropriated to shoulder the costs or expenses that may be incurred subject to the usual accounting and auditing rules and regulations.

RESOLVED FINALLY, let copy of this Resolution be furnished to the Public Employment Services Department (PESD), all Barangays, and all other offices concerned for their information, guidance and reference.
