RESOLUTION NO. 3625, S-2025

A RESOLUTION AUTHORIZING THE UTILIZATION OF THE SEAL OF GOOD LOCAL GOVERNANCE (SGLG) INCENTIVE FUND (SGLG-IF) AMOUNTING TO TWO MILLION PESOS (PHP2,000,000.00) FOR THE PURCHASE OF TWO (2) UNITS OF TRANSPORT VEHICLES AND OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) SOURCED FROM THE GENERAL FUND TO SUPPLEMENT SHORTAGES IN THE PURCHASE OF THE AFOREMENTIONED VEHICLES

WHEREAS, Republic Act No. 11292 or "The Seal of Good Local Governance Act of 2019" serves as the enabling act for the recognition of the performance of local government units (LGUs) in the transparent and accountable use of public funds, preparedness for challenges posed by disasters, sensitivity to the needs of vulnerable and marginalized sectors of society, implementation of health programs, investment and employment promotion, protection of constituency from threats to life and damage to property, and safeguarding the integrity of the environment;

WHEREAS, under Sections 11 and 12 of the afore-cited law, the use of the Seal of Good Local Governance (SGLG) Incentive Fund (SGLG-IF) granted to LGU-awardees shall be governed by the policies stated under the law;

WHEREAS, the City of Mandaluyong, as an awardee of the most coveted Seal of Good Local Governance (SGLG) granted by the Department of the Interior and Local Government (DILG), received an incentive for its distinct and remarkable good governance performance amounting to Two Million Pesos (Php2,000,000.00) ("SGLG-IF");

WHEREAS, the City, in its efforts to concretize the apparent benefits of its performance in the field of governance, intends to utilize the funds to purchase two (2) transport vehicle units, with such vehicles possessing identifiable markers compliant with the SGLG-IF standards;

WHEREAS, in compliance with the requirements of the DILG for its utilization, the City Government of Mandaluyong, through its Treasurer and Budget Officer, has already issued a Certificate of Availability of Funds, attached herein as Annex "A", treating the procurement of these vehicle units as a priority project of the City as incorporated in its City Annual Investment Plan for 2025 and allocating and making the same available for the said purpose;

WHEREAS, the City Government has received from the Department of the Interior and Local Government (DILG) City Director a Notice to Implement (NTI), attached herein as Annex "B", the procurement of two (2) Units Transport Vehicles to be charged against the 2024 SGLG-IF amounting to PhP2,000,000.00;

WHEREAS, foreseeing the possibility that the SGLG-IF Fund will be insufficient to purchase the afore-mentioned vehicles, it is necessary that the SGLG-IF Fund be supplemented by additional funding from a counterpart source contained in the General Fund of the City;

WHEREAS, for this purpose, a fund amounting to One Million Five Hundred Thousand Pesos (Php 1,500,000.00) is available for utilization in the Capital Outlay – Motor Vehicles account of the General Fund (“Supplementing Fund”), as evidenced by a Certificate of Availability of Funds issued by the City Treasurer and City Budget Officer, attached herein as Annex “C”;

WHEREAS, to enable the City Government of Mandaluyong to consummate the purchase of the afore-mentioned vehicles, the authority of the Sangguniang Panlungsod for the utilization of both the SGLG-IF and the Supplementing Fund is necessary.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the utilization of the Seal of Good Local Governance (SGLG) Incentive Fund (SGLG-IF) amounting to Two Million Pesos (P2,000,000.00) for the purchase of two (2) transport vehicle units;

RESOLVED FURTHER, that authority is likewise granted to utilize a supplemental fund amounting to amounting to One Million Five Hundred Thousand Pesos (Php 1,500,000.00) taken out of the counterpart account in the City’s General Fund, particularly Capital Outlay – Motor Vehicles account under the General Services Department, to cover any shortage in the purchase prices of the vehicles intended to be purchased;


RESOLVED FURTHER, that Honorable City Mayor BENJAMIN S. ABALOS is authorized to enter into and sign relevant documents pertaining to the purchase of the said vehicle units in accordance with the provisions of Republic Act No. 9184, its Implementing Rules and Regulations, and other applicable rules on procurement;

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor, City Planning and Development Department, City Budget Department, City Accounting Department and City Treasurer’s Department for their information, guidance and appropriate actions.

RESOLVED FINALLY, that This Resolution shall take effect immediately upon its approval.






