**A RESOLUTION COMMENDING THE HONORABLE  
CARMELITA A. ABALOS FOR HER GENUINE  
COMMITMENT, OUTSTANDING LEADERSHIP,  
AND EXEMPLARY PUBLIC SERVICE AS VICE  
MAYOR OF THE CITY OF MANDALUYONG**

WHEREAS, the Honorable Carmelita A. Abalos was elected in 2022 as the first-ever woman Vice Mayor of Mandaluyong City, and was unanimously chosen as National Vice President for Operations of the Vice Mayors' League of the Philippines (VMLP), a testament to her leadership on both local and national platforms;

WHEREAS, she has consistently distinguished herself as an award-winning public servant, having received numerous accolades and recognitions during her tenure as City Mayor for her exemplary performance, resolute dedication, and unwavering commitment to excellence;

WHEREAS, in her stint as Vice Mayor and Presiding Officer of the 12th Sangguniang Panlungsod, she exhibited distinguished leadership, dedication, and integrity that significantly advanced the City's legislative functions and supported the City Government's mission to provide responsive and efficient governance;

WHEREAS, during her ongoing term from July 1, 2022 to June 30, 2025, Vice Mayor Abalos has thus far presided over 144 Council Sessions, composed of 127 Regular Sessions and 17 Special Sessions, demonstrating effective legislative stewardship and dedication to democratic governance;

WHEREAS, under her capable leadership, the 12th City Council enacted a total of 74 vital ordinances and 481 resolutions, which addressed crucial issues and contributed to the City's continued progress, peace, and prosperity;

WHEREAS, Vice Mayor Abalos actively championed initiatives in advancing programs that uplifted key sectors, such as education, public safety, health, infrastructure, social services, and inclusive development, reflecting her compassion, strategic vision, and deep commitment to community empowerment;

WHEREAS, as Chairperson of the Committee on People's Participation, she was instrumental in promoting transparency, open and participatory governance, leading to the accreditation of nearly 200 Civil Society Organizations (CSOs), and solidifying Mandaluyong's reputation as a model for citizen-inclusive policymaking;

WHEREAS, her legacy as the first woman Vice Mayor has inspired greater inclusivity in leadership and set a high standard of performance and ethical conduct in public office;


WHEREAS, her remarkable service has earned the respect and admiration of her colleagues and constituents alike, making a lasting impact on the City and leaving behind a legacy of governance defined by compassion, vision, and accountability.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, hereby RESOLVES to commend and honor the Honorable CARMELITA A. ABALOS for her unwavering commitment, outstanding leadership, and sincere public service as Vice Mayor of the City of Mandaluyong.
