RESOLUTION NO. 3531, S-2024

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR BENJAMIN S. ABALOS TO SIGN THE DEED OF DONATION FROM THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) FOR THE ACCEPTANCE OF TWO (2) AMBULANCE UNITS

WHEREAS, Section 16 of the Local Government Code provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the above-mentioned Section also mandates local government units to promote health and safety of its constituents;

WHEREAS, the City recognizes the primal right of the people to health within the City Government of Mandaluyong;

WHEREAS, the Department of Health (DOH) is the government agency mandated to ensure equitable access to quality health for all Filipinos;

WHEREAS, the DOH launched the Health Facilities Enhancement Program (HFEP) to improve the delivery of health services through the upgrading of health facilities;

WHEREAS, pursuant to the HFEP, the DOH, through the DOH-MMCHD, offered to donate two (2) ambulance units to the City;

WHEREAS, a Deed of Donation is necessary to facilitate the transfer of ownership of the ambulance units to the City;

WHEREAS, the Local Government Code requires that a Sanggunian Resolution be issued first before the Local Chief Executive may be authorized to sign contracts in representation of the Local Government Unit;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session duly assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor BENJAMIN S. ABALOS to accept the donation of two (2) ambulance units from the DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT and sign the corresponding Deed of Donation.

RESOLVED FURTHER, that copy of this Resolution be furnished to the Office of the City Mayor, Department of Health-Metro Manila Center for Health Development, City General Services Department, City Health Department and other pertinent departments and offices.
